Age and sex: Estimates of population by detailed age and sex are used in all areas of policy, both in itself and as denominators in calculating rates. The GLA population projection model includes estimates by single year of age by sex that are benchmarked on census estimates. There is currently no alternative source at local level. It has not yet been demonstrated that a single or combination of administrative sources would provide statistics of appropriate quality for London. It is hence uncertain what the consequences would be.

Marital or legal partnership: Not used so extensively. Does play a role in planning service delivery. There is currently no alternative source. The consequences of losing these data would be less severe than for other demographics.

Household and family relationships: Used in determining rates of household composition in household projections, planning need for housing and social services amongst others. There is currently no alternative source.

The GLA has responsibility for enabling appropriate housing provision across London as set out in the London Plan and Statutory Housing Strategy. The GLA provides more than £400m a year in funding for affordable and accessible housing. To meet these requirements the GLA must have information on the current and future housing needs of London's population both in aggregate and at local level, and the characteristics of residents.

The Census is the only source of local level information on accommodation type, tenure and self-containment. Without these it would impossible to benchmark the state of the housing stock in London and plan for future housing need.

Rooms and bedrooms are used to measure household overcrowding. The more appropriate measure is that based on number of bedrooms, however for historical comparability the rooms measure is required. This latter measure is also used in CLG Index of multiple deprivation.

Access to Cars is an important component of residents' mobility and hence ability to access services. Data on registration of vehicles may become available from DVLA. It would need to be demonstrated that this source can be used to proxy household members' access to vehicles.

Although the proportion of London households who reported no central heating was relatively low, generally less than 5 per cent for most wards, the proportions with gas central heating varied greatly from over 90 per cent to less than 50 per cent. Type of central heating is important in measuring heating costs and hence the incidence of fuel poverty in London.

There is no alternative source for tenure, type of central heating. Counts of properties by rooms and accommodation type might be available from VOA, but would not have information about household residents.

It would hence not be possible for GLA to update much of the evidence base for the London Plan and specifically for the London Housing Strategy. Without data on numbers of rooms it would not be possible to construct a consistent time series of overcrowding.

Data on registration of vehicles may become available from DVLA but this would not be a measure of household members access to cars. It would hence not be possible to measure this aspect of access to services.

There was no information on the scale of language use across London and only anecdotal information on its geographical spread. Given the rate of population churn in London,

information from 2011 will be very out of date by 2021. Without this question we would not be able to plan foreign language services even in aggregate across London

Proficiency: GLA has a duty to ensure ESOL provision across London meets demand. Proficiency data are required to assess demand. Lack of English language proficiency is associated with poor economic outcomes. Without this information GLA would not be able to monitor the effect of proficiency on London's workforce, and plan for its alleviation.

There is no alternative source of international migration. I would guess that we would have to apply national migration assumptions to London, which would be very crude and so producing accurate London population projections would be compromised. Producing projections for smaller areas would probably not be possible. Internal migration could be estimated using NHS registrations but this has variable biases by age and sex. Other characteristics of migrants such as ethnicity would not be captured.

APS contains data on citizenship and country of birth but due to sample size, this would not be available in characteristic or geographical detail.
