The SNB was advised by email that: "the budget for the SNB projects is £27,354. The three currently submitted add up to £36,899, £9535 over spent. Do you want to reduce funding to one or more of the projects or submit something else in line with the budget"

In light of this the SNB submitted a reduced application for Personal Safety & Self Defence.
