Title: Social Media Hub to tackle Serious Gang Violence

Executive Summary:

This paper requests approval to draw down approved funding of £1.4m for a bid offered by the Home Office in October 2018 to set up and run a Social Media Hub proof of concept to tackle serious gang violence nationally. The Hub will bring together a dedicated team of police officers and staff to take action against online material, focusing on investigative, disruption and enforcement work against specific gang targets, as well as making referrals to social media companies so illegal and harmful content can be taken down.

It will have a London focus initially due to the volume of gangs and therefore content available, which in turn allows for full assessment of what works as best practice. It will introduce other forces content for Open Source assessment as the concept develops.

Recommendation:

The Deputy Mayor for Policing and Crime is recommended to:

- Approve a national Social Media Hub proof of concept that will allow more suitable resourcing dedicated to effectively tackling gang violence driven through inflammatory content, and tackle the linked serious criminality by exploiting technology and new approaches. This will start with a London focus before widening to other metropolitan forces.
- Approve that funding already offered for £1.4m from the Home Office can be drawn down. with mutually agreeable outcomes, that it is appropriate and will be sufficient to pay staffing and officer costs to those seconded to the hub.
- Approve that the exit strategy, on completion of the proof of concept, is delivered across Q4 FY 2019/20 to ensure no ongoing costs to the MPS or other UK Forces beyond that period.

1. Introduction and background

- 1.1. The funding is to enable the creation of a new hub under the NPCC banner that seeks to build on the lessons learnt of Operation Domain, and service wider demands across the MPS and larger UK metropolitan forces. It seeks to:
 - Build capabilities, by integrating expertise cross agency and industry;
 - Develop innovations such as maximising use of machine learning and AI;
 - Suppress and prevent real life serious violence.
- 1.2. The social media hub will initially look to target the highest harm gangs in London using both Open Source intelligence and direct operational support using other tactics. It will quickly introduce processing of Open Source content for other forces if the AI options are successfully tested in a linked proof of concept. These tools will then be mirrored in the Hub.

2. Issues for consideration

- 2.1. The scale of the threat nationally is unclear as there are no joined up systems, processes or partnerships in place. This proof of concept seeks to answer the unknown and provide:
 - Advice and guidance: law enforcement (forces, ROCUs) will gain access to the most effective ways
 of disrupting and dealing with online violent content;
 - Enhanced understanding of how gangs' on- and off-line activities interact, including with wider criminal networks;
 - The work of the social media hub is likely to be an important element in meeting expectations contained within the final version of the Online Harms White Paper.
 - Prevention and suppression of real violence.

3. Financial Comments

- 3.1. The cost of this work, £1.4m, covers staffing and support costs and will be funded through the approved bid to the Home Office.
- 3.2. A phased exit strategy in Q4 2020 will ensure no ongoing costs to any MPS or other forces funding, unless any such strategy is superseded by further Home Office funding to embed the concept for a further timescale.

EXECUTIVE SUMMARY

This Business Justification concerns the approval to draw down approved funding of £1.4m for a bid offered by the Home Office in October 2018.

This funding is to set up and run a Social Media Hub proof of concept to tackle serious gang violence nationally. The MPS will be the host force of the proof of concept due to DAC Ball's oversight of it, as he holds the NPCC Gangs portfolio. The staffing of the Hub will come from across policing units for a period of 12 months from FY 2019 to 2020.

It seeks to bring together a dedicated team of police officers and staff to take action against online material, focusing on investigative, disruption and enforcement work against specific gang targets, as well as making referrals to social media companies so illegal and harmful content can be taken down.

It will have a London focus initially due to the volume of gangs and therefore content available, which in turn allows for full assessment of what works as best practice. It will introduce other forces content for Open Source assessment as the concept develops.

Key strategy and best practice is to be developed in partnership with other agencies and third sector to enhance the law enforcement response. The Hub is necessary to ensure that a dedicated resource with adequate skills and knowledge is maintained for upmost progression in this arena, and build digital solutions to improve capability across the UK.

- 3. Approve that the exit strategy, on completion of the proof of concept, is delivered across Q4 FY 2019/20 to ensure no ongoing costs to the MPS or other UK Forces beyond that period.

Time sensitivity
