Thank you for your further correspondence which the Greater London Authority (GLA) received on 7 October 2020 and 15 October. Your request has been dealt with under the Freedom of Information Act 2000

## You asked for:

- 1. Natural England's "statements" as referenced in the email you have "reproduced" to me (as dated 7/12/18 at 11.37) with evidence that they were sent from Natural England as part of the same email correspondence?
- 2. a screenshot of the email received from Natural England on 7 December 2018 at 11.37 showing that the email is authentic and that it was sent with an attachment?
- 3. a screenshot of the "properties" section of the attachment purportedly sent with the email from Natural England on 7 December 2018 showing when the document was created?

The email dated 7 December 2018 11.37 which you say is from Natural England does not include the attachment mentioned in the email. The message also does not include any symbol that shows there was an attachment on the email. Indeed there is no evidence that the wording you have sent me is part of an email or that it is taken from a missive that was sent from Natural England.

I request that you send me information that leaves no doubt as to its authenticity or date of production/ on which it was sent.


