Thank you for your freedom of information request which the Mayor's Office for Policing And Crime (MOPAC) received on 23 March. I can confirm that your request has been handled under the Freedom of Information Act 2000 and that MOPAC does hold some information relating to your request.

Our response to your requests are as follows:

As of 29th March 2022, 36 Knife Crime Prevention Orders have been granted.

MOPAC does not hold up to date information on the demographical breakdown of issued Knife Crime Prevention Orders.

MOPAC does not hold this information.

4. How many Knife Crime Prevention Orders were issued to individuals believed to be habitual knife carriers?

MOPAC does not hold this information.

5. How many applications have been made by the police to the courts for Knife Crime Prevention Orders? How many orders were granted? How many orders were rejected? Of the Knife Crime Prevention orders that were rejected, please provide reasons why.

As of 29th March 2022, 69 applications resulted in a court hearing, 36 were granted and 33 rejected.

MOPAC does not hold information on the reasoning behind rejected Knife Crime Prevention Orders.

6. Can you share any data you have on courts providing positive intervention? Such as such as educational courses, sports club referrals, relationship counselling, anger management, mentoring and drug rehabilitation.

When an application is made by the MPS to the court, the MPS must outline the intervention that will be attached to the order. The Court will not provide the positive intervention.

MOPAC does not hold information regarding the breakdown of what interventions have been attached to the 36 orders granted.

7. Have any Knife Crime Prevention Orders been breached? If so, please share the criminal offence that was handed to the individuals who breached the orders.

MOPAC does not hold this information.
