



Overall, the AEB procurement will result in 2 contracts across Lot 1 and Lot 2 for the total value of £130m over four academic years 2019-2023. The chart below shows that approximately 66% of the funding goes to London based providers as opposed to 34% allocated to providers based outside London.





The AEB Procured contracts are expected to involve a good mix of 71 delivery providers including both lead partners and their subcontractors. Please see the chart below:



The two charts below map the total number of learners expected to benefit from the AEB contract provision across the four London subregions who surpass 100,000 people across both Lots.
