Thank you for your Freedom of Information (FOI) request of 22 June to the Mayor's Office for Policing And Crime (MOPAC). I confirm that your request has been handled under the FOI Act 2000 and that MOPAC does hold information relating to your request. Please see responses below.

- (a) all 'progress against strategic targets/actions' as set out in the above plan? (2017-2021)

The Police and Crime Plan 2017/2021 specifically moved away from rigid targets and took a new approach to setting priorities so that more attention was paid to complex high harm crimes, whilst also giving local leaders more control to take action of crimes that affect their residents the most. Progress on local priorities is shown in the quarterly performance pack.

The Plan set out 119 commitments to deliver over the four years. 87% are either complete or we have full confidence will be completed. Work continues to progress all outstanding commitments, with progress being discussed monthly through MOPAC's governance processes.

(b) All 'progress against actions' as set out in combined Joint Delivery Plans? (implementation plans).

Delivery of commitments where there was a partnership element to the response have been managed through sub-boards of the London Crime Reduction Board. Minutes of these boards and other scrutiny mechanisms can be found on our website.
