Our Youth Zones ran more than 350 (online and physical)

activities in the 6 week summer period, providing meals to young people at many of the activities.

Placing difference at the centre of the development of any of our participation work and celebrating this will ultimately make this work more effective in promoting inclusive ways of working and thinking for youth workers and young people alike.

We've made specific provision for Young Carers, Looked after Children, LGBTQ+, and SEND young people. Whilst having the ability to place particular focus on these cohorts of young people, as a team we are also conscious of the dangers of only looking at a young person through the lens of one aspect of their experience, and recognise that we have to take an intersectional approach.
