Thank you for your request for information which the Greater London Authority (GLA) received on 7 February 2020. I am sorry for the delay in responding. Your request has been dealt with under the Freedom of Information Act 2000.

You requested:

Copies of all letters / emails and/ or minutes of any meetings between Boris Johnson, when Mayer and Douglas Oakervee, concerning the Thames Estuary Airport, including the Steering Group / Thames Estuary Research and Development Company (Testrad) and /or Thames Estuary Airport Feasibility Review, from 1 November 2008 until 31 December 2009.

Our response to your request is below:

We have located three letters in scope, which are attached with some minor redactions. Please note that some names of members of staff are exempt from disclosure under s.40 (Personal information) of the Freedom of Information Act. This information could potentially identify specific employees and as such constitutes as personal data which is defined by Article 4(1) of the General Data Protection Regulation (GDPR) to mean any information relating to an identified or identifiable living individual. It is considered that disclosure of this information would contravene the first data protection principle under Article 5(1) of GDPR which states that Personal data must be processed lawfully, fairly and in a transparent manner in relation to the data subject.
