Thank you for your request for information which the Greater London Authority (GLA) received on 10 March 2020. Your request has been dealt with under the Freedom of Information Act 2000

You asked for:

Following up from previous FOI requests about meetings with industry actors during the development of the TfL HFSS advertising ban, please can you also share the following: Dates and attendees (roles are sufficient) of meetings with NGOs regarding the ban of HFSS food advertising on the TfL estate between April 2018 and January 2019.

Moreover, in e-mails released through a previous request (via e-mail), Yum Brands (KFC) notified Paul Lindley of some research on 'youth eating and snacking behaviour' they had conducted.
