## Dear

Thank you for your request for information which the Greater London Authority (GLA) received on 24 June 2020. Your request has been dealt with under the Freedom of Information Act (FOIA) 2000.

You asked for:

The GLA "to create / generate a report / spreadsheet for each of the boroughs listed: Barking & Dagenham / Havering / Newham / Redbridge / Tower Hamlets / Waltham Forest / Hackney

Providing full details of all any Land, Property, Buildings or Residential property that is Disused / Derelict / Distressed and is currently vacant, inc street name, postcode, size, est. value, cost etc.

Can you also provide details of the main contact person responsible for land / property asset management for each of the London borough listed above.

Our response to the other requests is as follows:

Please find a table setting out details of the assets identified and their location.

Please note all the sites are earmarked for redevelopment or are in the process of being developed. We therefore consider that the size and value of each asset is exempt from disclosure under section 43 (2) (Commercial interests) of the FOIA. This provides that information can be withheld from release if its disclosure would, or would be likely to, prejudice the commercial interests of any person, including those of the GLA.

A commercial interest relates to a person's ability to participate competitively in a commercial activity. The GLAP portfolio is subject to wider development plans. In order to make these developments viable, commercial discussions are required with third parties who support the GLA in developing the areas. During these discussions the land and assets values will be negotiated. The GLA's position would be prejudiced should this detailed information become public knowledge and would be likely to undermine our ability to achieve best value for the sites.

## GREATER LONDON AUTHORITY

Section 43(2) constitutes a qualified exemption from our duty to disclose information under the FOIA and consideration must be given as to whether the public interest favouring disclosure of the information covered by this exemption outweighs the public interest considerations favouring maintaining the exemption. In this instance we consider it not to be in the public interest to release information that would be likely to affect the GLA's position in negotiations and reduce the GLA's ability in securing best value for the public purse.
