Thank you for your further correspondence.

In relation to the list of the 10 largest developments on GLA land or Joint Venture interests provided to you on 21 February 2019, please find below the additional information you require to the extent that the GLA holds the information. As previously advised, the GLA is London's strategic government and we are not usually the direct client of construction works on sites where we have a land or joint venture interest and therefore don't hold full project contract values which can inform your request in full.

Please note that some information regarding the value of some of the contracts is being withheld under section 43 (2) (Commercial interests) of the FOIA. This provides that information can be withheld from release if its disclosure would, or would be likely to, prejudice the commercial interests of any person, including those of the GLA.

A commercial interest relates to a person's ability to participate competitively in a commercial activity and in this instance, involves information about 'live' sites which are subject to negotiations and ongoing commercial dialogue.

Section 43(2) constitutes a qualified exemption from our duty to disclose information under the FOIA and consideration has to be given as to whether the public interest favouring disclosure of the information covered by this exemption outweighs the public interest considerations favouring maintaining the exemption and withholding the information. In this instance we regard it not to be in the public interest to release information that would be likely to affect the way in which third parties are able to negotiate matters on 'live' sites.
