Title: Grant funding for the National Policing Data Communications Group Futures Group and Communications Data Delivery and National Communications Delivery Service

Executive Summary:

The Metropolitan Police Service has received grant funding from the Home Office (HO) for the National Policing Data Communications Group Futures Group since 2007 and the Communications Data Delivery and National Communications Delivery Service since 2015.

This funding has previously been formalised under an umbrella grant agreement between the HO and MOPAC for the Communications Capabilities Development Programme (CCD).

The most recent of these agreements expired on 31 March 2018 and the HO have now drafted new grant agreements for each of these funding streams to cover the current and next financial years.

The Deputy Mayor for Policing and Crime is asked to approve the continuation of HO grant funding for the National Policing Data Communications Group Futures Group and Communications Data Delivery and National Communications Delivery Service.

Recommendation:

The Deputy Mayor for Policing and Crime is recommended to:

- Approve the continuation of grant funding from the Home Office for the National Policing Data Communications Group Futures Group for the period from 1 April 2018 to 31 March 2020. The value of the grant is £1,046,000 per year.
- Approve the continuation of grant funding from the Home Office for the Communications Data Delivery and National Communications Delivery Service for the period 1 April 2018 to 31 March 2020. The value of the grant is £130,078 per year.

1. Introduction and background

- 1.1. The National Policing Data Communications Group (DCG) Futures Group is a sub-group of the National Policing DCG. The group was formed to address the challenges that an increasingly sophisticated and ever-changing communications environment poses for the National Law Enforcement community. The group is concerned with an improved understanding of existing technologies and exploring the impact of new technology and services on investigators.
- 1.2. The Home Office (HO) have funded the DCG Futures Group since 2007. This funding has previously been formalised under a series of umbrella grant agreements between the HO and the Mayor's Office for Policing and Crime (MOPAC) for the Communications Capabilities Development (CCD) Programme, which were approved and signed by the MOPAC. However, the most recent grant agreement for the CCD programme expired on 31 March 2018 and HO have now issued a new grant agreement to formalise the funding of the DCG Futures Group for the next two financial years.

2. Issues for consideration

2.1. DCG Futures are leading and supporting a number of national projects which are scheduled for completion during 2019 / 20. The projects assist across a wide variety of policing roles which directly impact on the prevent, protect and pursue strategy.

EXECUTIVE SUMMARY

The Metropolitan Police Service has received grant funding from the Home Office (HO) for the National Policing Data Communications Group Futures Group since 2007 and the Communications Data Delivery and National Communications Delivery Service since 2015.

This is because the MPS is currently incurring expenditure for the funding of the National Policing Data Communications Group Futures Group and Communications Data Delivery and National Communications Delivery Service for the 2018/19 financial year and needs to reclaim this money from the Home Office.

Introduction and background

National Policing Data Communications Group (DCG) Futures Group

- 1. The National Policing Data Communications Group (DCG) Futures Group is a sub-group of the National Policing DCG. The group was formed to address the challenges that an increasingly sophisticated and ever-changing communications environment poses for the National Law Enforcement community. The group is concerned with an improved understanding of existing technologies and exploring the impact of new technology and services on investigators.
- 2. The Home Office (HO) have funded the DCG Futures Group since 2007. This funding has previously been formalised under a series of umbrella grant agreements between the HO and the Mayor's Office for Policing and Crime (MOPAC) for the Communications Capabilities Development (CCD) Programme, which were approved and signed by the MOPAC. However, the most recent grant agreement for the CCD programme expired on 31 March 2018 and HO have now issued a new grant agreement to formalise the funding of the DCG Futures Group for the next two financial years.
- 3. The grant of £1,046,000 funds staff and resource costs, maintaining and improving existing capability, new capability, research and development and communications and training.
- 4. DCG Futures work with all UK law enforcement and industry partners on new and emerging communications technology. The findings directly result in the development/delivery of tools and products to assist investigators. Training programmes are developed and delivered for first responders through to senior officers and criminal justice partners.

Communications Data Delivery and National Communications Delivery Service (Communications Data Account Manager)

5. The Communications Data Account Manager (CDAM) acts as a conduit between the National Communications Data Service (NCDS) and the regional Law

Enforcement Agencies (LEA) (and wider Public Authorities (PA)). Their role is as follows:

- a. Maintain effective day-to-day communications between the CD LEA/PA Community and the NCDS.
- b. Ensure NCDS strategic thinking aligns with the operational needs of the LEA and PA.
- c. Raise issues and risks relating to communications data on behalf of the LEA/PO Community with the relevant Pods within NCDS
- d. Facilitate meetings and briefings between NCDS and their designated LEA/PA regions
- e. Ensure that CD opportunities are being maximised by the LEA or PA Community
- f. Assist NCDS in prioritising new CD capabilities for the LEA and PO Community
- 6. The Home Office have funded the CDAM since 23 February 2015. This funding has previously been formalised under a series of umbrella grant agreements between the Home Office and the Mayor's Office for Policing and Crime (MOPAC) for the Communications Capabilities Development (CCD) Programme, which was approved and sign by the MOPAC. However, the most recent grant agreement for the CCD programme expired on 31 March 2018 and HO have now issued a new grant agreement to formalise the funding of the CDAM for the next two financial years.
- 7. The grant of £130,078 funds the cost of a Detective Superintendent, support costs and travel and subsistence.

Issues for consideration

- 8. DCG Futures are leading and supporting a number of national projects which are scheduled for completion during 2019 / 20. The projects assist across a wide variety of policing roles which directly impact on the prevent, protect and pursue strategy.
- 9. The MPS acquires more Communications Data than any other Law Enforcement Agency in the UK. However, the use of Communications Data by Law Enforcement and Public Authorities has undergone significant legal challenges in recent years. In April 2019, the Investigatory Powers Act is going to transform how the MPS authorises, acquires, stores and retains Communications Data. New legislation, application forms, authorisation processes, training and CD workflows will each bring about new challenges. The MPS CDAM will ensure that MPS interests are represented across government and that transition to the new ways of working are managed effectively.

Contributes to the MOPAC Police & Crime Plan 2017-2021¹

10. DCG Futures research and findings are disseminated across UK law enforcement to ensure investigators are aware of the operational risks and

opportunities of new and emerging technology. This assists with priorities highlighted in the Police and Crime Plan such as keeping children and young people safe and violent crime against women and girls.

Financial, Commercial and Procurement Comments

- 11. All the cost shown for the DCG Futures Group and CD Account Manager will be recovered from the HO under new grant agreements between HO and MOPAC. These costs were previously recovered from the HO under an umbrella grant agreement covering CCD.
- 12. The Home Office have confirmed that grant funding is available for the DCG Futures Group and CD Account Manager for the next two years. The HO have already issued grant agreements for this funding, which will be signed and the funding claimed once approval has been received from the DMPC. There are no financial risks to the MPS.
- 13. The DCG Futures Group are an integral part of the new National Communications Data and Legal Interception (CDLI) Partnership. There are plans for the Partnership staff and services to be permanently funded from March 2020 through the HO, who are part of the partnership. The long-term discussions will also explore the physical location of the staff, which subject to agreement would have the futures group remain within the MPS.
- 14. Should the Home Office cease funding for the CDAM role in the MPS at the end of the funding period, there would be two options. The first option would be to allocate money from the existing MPS budget to fund the post, which in the current climate could be problematic. The second option would be to transfer the CDAM responsibilities to another Superintendent and accept the role can no longer be full time role. The SRO for Communications Data in the MPS is also the operational head of the Communications Intelligence Unit (CIU), the Internet Intelligence and Investigation Unit (III), the Automatic Number Plate Recognition Unit (ANPR) and the Horizons (Projects) Team. As such they already have a good understanding of the issues managed by the CDAM and would be best placed to take on this role.'
