Thank you for your requests for information which the Greater London Authority (GLA) received on 20 December 2019. Your request has been dealt with under the Freedom of Information Act (FOI) 2000.

Our response to your requests is as follows:

1. To request (i) total number of staff employed by the Mayor at City Hall who work in press or handle media (ii) total spend on salaries for this group, for the last financial year.

4. To request the total number of staff - whom are categorised as political appointees - currently have access to City Hall, for example deputy mayors and advisers?

There are 13 Mayoral Appointments and 1 Statutory Deputy Mayor appointed under Section 67¹ of the Greater London Authority Act 1999.

The 13 Mayoral Appointments are broken down as follows:

- 7 x Deputy Mayors
 - 1. Education & Childcare,
 - 2. Planning Regeneration & Skills,
 - 3. Culture & Creative Industries,
 - 4. Social Integration, Social Mobility, Community Engagement
 - 5. Business
 - 6. Environment & Energy
 - 7. Transport
- 4 x Mayoral Directors
 - 1. Policy
 - 2. Communications
 - 3. External & International Affairs
 - 4. Political & Public Affairs
- 1 x Chief of Staff
- 1 x Deputy Mayor Fire & Resilience

The Statutory Deputy Mayor Appointment is a dual role held by Joanne McCartney (Also one of the 7 deputy Mayors – Education & Childcare)

Further, under the Police Reform and Social Responsibility Act 2011 (Section 19²), The Mayor may appoint a Deputy Mayor for Policing and Crime.

5. To request the total number of staff employed at City Hall, in any capacity, on salaries as banded below: Less than £20,000, £20,001 - £30,000, £30,001 - £40,000, £40,001 - £50,000, £50,001 - £60,000, More than £60,000
