- 2. To provide approval to initiate and award five Single Action Tenders totalling £344,500.

1. Introduction and background

- 1.1 The TSU is a sensitive unit, employing covert tactics and methods against the most serious and organised and Counter Terrorist (CT) operations.
- 1.2 The capital replacement will remove unnecessary running costs and provide the necessary technological uplift to maintain operational service delivery. It will also provide greater resilience moving forward and is in keeping with the advances in technologies, ensuring the TSU are able to tackle emerging threats.

3. Financial Comments

3.1. The cost of £933,500 will be funded from the £2.5m available in 2016/17 capital programme for Specialist Crime and Operations 35. There will be no ongoing revenue costs associated with this capital replacement.
