

**THE TOWN AND COUNTRY PLANNING ACT 1990
THE TOWN AND COUNTRY PLANNING (GENERAL DEVELOPMENT
PROCEDURE) ORDER 1995
DIRECTION UNDER ARTICLES 10 AND 27 RELATING TO WALBROOK
WHARF**

The Secretary of State for the Environment, Transport and the Regions in exercise of the powers conferred on him by articles 10(3) and 27 of the Town and Country Planning (General Development Procedure) Order 1995 (a) and all other powers enabling him in that behalf, hereby directs the Corporation of London as follows:-

1. In this Direction-
"Corporation" means the Corporation of London;
"Mayor" means the Mayor of London; and
"Mayor of London Order" means the Town and Country Planning (Mayor of London) Order 2000 (b).
2. (1) This Direction shall come into force on 3 July 2000 and, subject to sub-paragraph (2) below, shall apply to any application for planning permission for development which is received by the Corporation on or after 3 July 2000 and which is for development wholly or partly within the area edged in red on the attached plan.

(2) This Direction does not apply to any application for planning permission to which paragraph 1(2) of the Schedule to the Mayor of London Order applies.
3. Before granting planning permission on any application to which this Direction applies, the Corporation shall consult the Mayor.
4. (1) Subject to sub-paragraph (2) below, the Direction given to the Corporation of London by the Secretary of State on 18 February 1997 under articles 10(3) and 14(1) of the Town and Country Planning (General Development Procedure) Order 1995 relating Walbrook Wharf is hereby cancelled.

(2) Sub-paragraph (1) does not apply to any application for planning permission-
 - (a) which is received by the Corporation on or before 2 July 2000, or
 - (b) to which paragraph 1(2) of the Schedule to the Mayor of London Order applies.

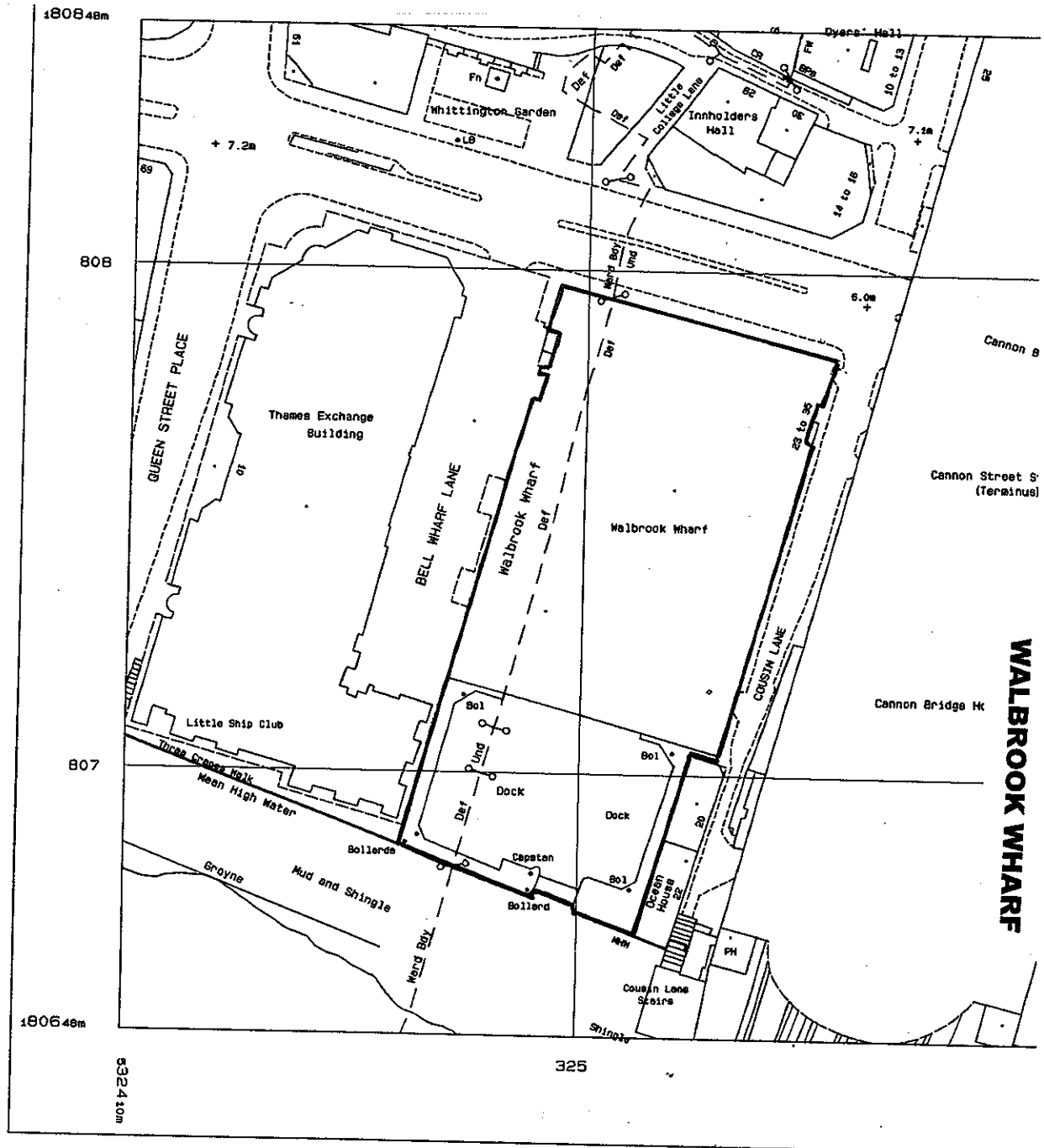
