## RESPONSE

Thank you for your Freedom of Information request of 17 January to the Mayor's Office for Policing And Crime (MOPAC) and I apologise for the delay in replying to you. I confirm that your request has been handled under the Freedom of Information Act 2000 and that MOPAC does hold some information relating to your request, as follows.

Many of the Violence Against Women and Girls (VAWG) projects funded through the London Crime Prevention Fund (LCPF) include outcomes to support victims of stalking, the details of the overall programmes are included below however it is not possible to disaggregate exactly how much has been assigned specifically to victims of stalking. Where details are available they have been provided in the table below:

As you will be aware, in 2017 MOPAC and the MPS, in collaboration with the Police and Crime Commissioners and police forces in Hampshire and Cheshire, together with the National Probation Service (NPS) and Crown Prosecution Service (CPS), have been brought together by the Suzy Lamplugh Trust to improve the response to stalking perpetrators. The partnership has bid successfully for £4m in shared funding from the Police Transformation Fund to trial a new approach to tackle the issues that drive this dangerous behaviour over a two period.
