Title: Volunteer Police Cadets Collaboration

#### **Executive Summary:**

This paper seeks approval to collaborate with the Police and Crime Commissioner (PCC) for Devon and Cornwall in developing the Volunteer Police Cadets across the UK. The Volunteer Police Cadets provides opportunities for engagement with young people, especially those from crime vulnerable backgrounds. It allows young people to make a positive contribution to their communities through supporting operational policing, crime prevention and community safety.

#### Recommendation:

The DMPC is asked to

1. Approve the collaboration agreement between the MPS and the Police and Crime Commissioner (PCC) for Devon and Cornwall. This will allow grant funding of £69,500 to be transferred to the MPS and further develop Volunteer Police Cadets across the UK.

#### PART I - NON-CONFIDENTIAL FACTS AND ADVICE TO THE DMPC

#### Decision required – supporting report

#### 1. Introduction and background

- The National Volunteer Police Cadets (NVPC) team seeks to support all UK police forces to be able to create, support and expand their cadet units. The Volunteer Police Cadets (VPC) is the primary engagement and diversion programme of the MPS. Over 5,000 cadets volunteer on a regular basis throughout London to support operational policing, crime prevention and community safety.
- 1.2 In April 2016, the PCC for Devon and Cornwall on behalf of the NVPC team was successful in bidding for £1.8m from the Police Innovation Fund (PIF) for 2 years to deliver a national digital platform, volunteer leader training and provide pump-priming grants to forces to support national VPC expansion and ongoing programme costs.

#### 2. Issues for consideration

2.1. The VPC budget for this financial year has been reduced and this has inevitably had an impact on the programme and the extent and range of activities that are offered. Without further funding units will have to undertake fundraising to be able to offer cadets additional opportunities.

#### 3. Financial Comments

- 3.1 The PPC for Devon and Cornwall has that requested English and Welsh forces collaborate with them as part of the national development strategy including the distribution of the £1.8m PIF grant. The funding provision to each police force is £2,000 for new senior VPC units and £1,500 for new junior units, which equates to £69,500 for 44 eligible MPS units.
- 3.2 The grant funding will provide additional capacity for the MPS and will not impact on the current budget for the Volunteer Police Cadet programme.

#### 4. Legal Comments

- 4.1. Under paragraph 4.5 of the MOPAC Scheme of Consent and Delegation approval is required by the Deputy Mayor for Policing and Crime for all collaboration agreements under s22 Police Act 1996 where the Act requires it.
- 4.2. There will be a written agreement between MOPAC and the PCC for Devon and Cornwall to formalise the arrangement. The agreement will be published under the Elected Local Policing Bodies (Specified Information) Order 2011.

#### 5. Equality Comments

- 5.1. The VPC Programme has a stated aim of including at least 25% cadets from crime vulnerable backgrounds and has consistently over-achieved on this target with the figure currently sitting at 34% across the MPS. Crime vulnerable cadets are recruited and identified using the Department for Children, Schools and Families (now the Department of Education) approved definition of Vulnerability signed off in 2011.
- 5.2. The additional funding will support the MPS's objectives to expand opportunities to disadvantaged voung people.

## Investment Advisory Board – February 2017 Report by ACTP on behalf of the Commissioner

#### SUMMARY

The Volunteer Police Cadets (VPC) is the primary youth engagement and diversion programme of the Metropolitan Police Service (MPS), with just over 5,000 cadets volunteering regularly across London to support operational policing, crime prevention and community safety. In 2015, cadets completed over 196,000 volunteer hours to supporting the MPS.

The National VPC (NVPC) team seeks to support and enable all UK police forces to create, support and expand their cadet units.

In April 2016, the PCC for Devon and Cornwall on behalf of the NVPC team were successful in bidding for £1.8m from the Police Innovation Fund (PIF) for 2 years to deliver a national digital platform, volunteer leader training and provide pump-priming grants to forces to support national VPC expansion and ongoing programme costs.

The allocation of the PIF grant is overseen by a programme board established by Devon and Cornwall Police as lead force. Devon and Cornwall Police have requested each English and Welsh force collaborate with them as part of the national development strategy, including the distribution of the PIF grant. The funding provision to each Force is £2,000 for new Senior VPC units and £1,500 for new Junior VPC units, which currently equates to £69,500 for the 44 eligible MPS units.

The collaboration with Devon and Cornwall along with the provision of further funding will complement and support the MPS VPC programme and the Deputy Mayor of Policing & Crime (DMPC) approval is now required, in accordance with the Mayor's Office of Policing & Crime's (MOPAC) Scheme of Consent and Delegation.

## A. RECOMMENDATIONS - That the Deputy Mayor for Policing and Crime;

- 1. Approves, in line with 4.5 of the MOPAC Scheme of Consent and Delegation, that a policing body collaboration with the Police and Crime Commissioner for Devon and Cornwall is formed for the further development of the Volunteer Police Cadets across the UK.
- 2. Approves the incorporation of the additional expenditure and funding, summarised in the financial implications section of this report, into relevant MPS budgets.

#### **B. SUPPORTING INFORMATION**

- 1. The MOPAC Policing and Crime Plan 2013-16 included a pledge from the Mayor of London to double the number of Cadets to 5,000 by April 2016. The VPC has now reached this target and these young people are actively and positively engaged in adding value to policing their communities across the MPS.
- 2. Since 2013, and with the support of NPCC, the NVPC team have managed £2.2m of grants from the Youth United Foundation, distributing pump-priming funds, which has allowed Forces to pilot cadet programmes and assess delivery; the funding has been

received by the MPS pursuant to Section 93 Police Act 1996 and the MOPAC Scheme of Consent and Delegation which allows for the acceptance of gifts of money under £50,000. These programmes were independently evaluated by Ecorys and proved to be among the most successful programmes funded. After extensive consultation, the NVPC team have developed the digital platform and training programme in response to needs of Force leads.

- 3. The MPS has the largest VPC programme in the UK representing 40% of the current national total of 12,500 cadets.
- 4. The current NPCC lead for Police Cadets is Chief Constable Shaun Sawyer based in Devon and Cornwall. In April 2016, the PCC for Devon and Cornwall on behalf of the NVPC team were successful in bidding for £1.8m from the PIF for 2 years to deliver a national digital platform, volunteer leader training and provide pump-priming grants to forces to support national VPC expansion and ongoing programme costs.
- 5. The allocation of the PIF grant is overseen by a programme board established by Devon and Cornwall Police. The PCC for Devon and Cornwall have requested each English and Welsh force collaborate with them as part of the national development strategy, including the distribution of the PIF grant. The funding provision to each Force is £2,000 for new Senior VPC units and £1,500 for new Junior VPC units, equating to £69,500 for the 44 eligible MPS units that are eligible in 2016/17. Further distribution of the PIF grant will be made through the collaboration and in line with the national strategy and PIF grant terms.
- There are no extra costs incurred to MOPAC as this funding will provide additional budget to support delivery of the existing Volunteer Police Cadet programme.

## C. OTHER ORGANISATIONAL & COMMUNITY IMPLICATIONS

## **Equality and Diversity Impact**

- The VPC Programme has a stated aim of including at least 25% cadets from crime vulnerable backgrounds and has consistently over-achieved on this target with the figure currently sitting at approximately 34% across the MPS. Crime vulnerable cadets are recruited and identified using the Department for Children, Schools and Families (now the Department of Education) approved definition of Vulnerability signed off in 2011.
- 2. This additional funding will support our objectives to expand opportunities to disadvantaged young people.

## Financial Implications / Value for Money

- This proposal seeks to bring into the VPC additional funds through accessing the PIF grant allocated to the PCC of Devon and Cornwall.
- The VPC budget for this financial year has been reduced and this has inevitably had an impact on the programme and the extent and range of activities that we are able to offer. Without further funding, units will have to undertake fundraising to be able to offer the cadets additional opportunities.
- 3. The funding will be used for activities in addition to the plans based on the current budget, for further the aims of the NVPC to:
  - a) Promote a practical understanding of policing amongst all young people

- b) Encourage a spirit of adventure and good citizenship
- c) Support local policing priorities through volunteering and give young people a chance to be heard
- d) Inspire young people to participate positively in their communities

#### **Legal Implications**

- 1. S22 of the Police Act 1996, as amended by Section 89 Police Reform and Social Responsibility Act 2011 allows the MOPAC, as the local policing body, in connection with the discharge of any its functions to enter into a collaboration agreement.
- 2. The MOPAC Scheme of Delegation at Clause 4.5 requires the Deputy Mayor for Policing and Crime to approve all collaboration agreements where the Act requires.
- 3. If approved, there will be a written agreement between the MOPAC and the PCC for Devon and Cornwall to formalise the arrangement. The agreement will be published under the Elected Local Policing Bodies (Specified Information) Order 2011.

## Risk (including Health and Safety) Implications

### **Health and Safety**

 The Volunteer Police Cadet programme is subject to a manual of guidance (MOG) and current H&S. This was signed off by TP COG in July 2014. This MOG contains policy guidance and is continually reviewed in consultation with colleagues from MPS Health and Safety and Insurance departments.
