Thank you for your request for information which the GLA received on 4 October 2018. Your request has been dealt with under the Freedom of Information Act 2000.

Our response to your request is as follows:

- A) The Office of Sadig Khan
- B) The Office of the deputy mayor for Transport

And Crossrail Ltd concerning progress of the construction of the Elizabeth Line from 1st January 2017 to date.

Please find attached the information we have identified as within scope of your request. Please note that the names of some members of staff and references to personal information is exempt from disclosure under s.40 (Personal information) of the Freedom of Information Act. This information could potentially identify specific employees and as such constitutes as personal data which is defined by Article 4(1) of the General Data Protection Regulation (GDPR) to mean any information relating to an identified or identifiable living individual. It is considered that disclosure of this information would contravene the first data protection principle under Article 5(1) of GDPR which states that Personal data must be processed lawfully, fairly and in a transparent manner in relation to the data subject.
