## **Lettings for Seaside & Country Homes - 2013/14 to 2018/19**

Thank you for your request for information regarding the Seaside & Country Homes Scheme which the Greater London Authority (GLA) received on 9 April. Your request has been dealt with under the Freedom of Information Act 2000.

You asked:

*Please tell me which London boroughs bought lettings for Seaside & Country Homes, and how many lettings each borough bought.*

*If you already have data for the above questions for 2019/20 please include that too.*

*Please also say how many tenants from each borough moved in each of those years.*

We can confirm that all boroughs participate in the scheme. The data you have requested is provided on the accompanying spreadsheets and we have included data for the year 2019/20 as you requested.

With regard to the numbers of lets purchased by the boroughs, the figures provided are those confirmed at the beginning of each year. In some cases, boroughs have committed to additional numbers during the year if necessary.

The total number of moves from each borough includes their own tenants and those from Housing Associations within that borough.

Please note that we have recorded the number of lettings by calendar year instead of financial year as this is the only way we can extract the data from the system. This will not affect the

total number of moves achieved over time however so are still an accurate total of the numbers of moves by borough.
