I am sure you saw the motion passed by the London Assembly yesterday on the housing and parking aspects of the so-called MALP.

The London Assembly was emphatic several times in saying that the proposed Parking changes are 'major' not 'minor'. They must not be pushed through by the Mayor at this time.

The London Assembly's formal motion adds great weight to Clean Air in London's earlier and recent objections.

CAL urges the Mayor again to drop his proposed changes to the London Plan on parking and consider them again only, if at all, when the whole London Plan is revised by the next Mayor.

I have copied Kate Harrison and Nicky Gavron and look forward to seeing the Mayor's decision.
