Thank you for your request for information which the GLA received on 17 April 2018. Your request has been dealt with under the Freedom of Information Act 2000.

Please find below the information we hold within the scope of your request.

What is the most recent available value of the local authority's pension fund?

• The value of the London Pension Fund Authority's (LPFA) fund at 28 Feb 2018 was £5.561bn.

What is the value of the fund's directly-held investment in shares or bonds of the following companies: British American Tobacco, Imperial Brands, Japan Tobacco International, Altria Group Inc, Philip Morris International, Universal Corp, Alliance One International?

• The LPFA does not have direct holdings in shares or bonds in these companies.

What is the total combined value of the fund's directly-held investments in the companies named above?

• The LPFA does not have direct holdings in shares or bonds in these companies.

What income did the fund receive from these investments in the last 12-month period for which records are available?

The LPFA does not have direct holdings in shares or bonds in these companies

Does the fund have any other investments in tobacco via pooled investments? What is the value of these?

• The LPFA does not directly hold shares or bonds in underlying companies, any investment interests in tobacco are via pooled funds.

The value of the Fund's interests in tobacco companies through pooled funds was £37.16m at 28 Feb 2018 (0.66% of the Fund).

Additionally, the LPFA has synthetic exposure to equities through investments in index-based futures. The equivalent interest in tobacco companies via these futures was £4.67m at 28 Feb 2018 (0.08% of the Fund)

What is the local authority's annual spend on smoking-related illness?

• The GLA is London's strategic government and does not operate in the same way as local authorities or the NHS. We do not spend any funding on smoking related illness.
