Title: Single Tender Action to purchase equipment for MPS firearms officers

## **Executive Summary:**

In light of recent global events and especially those in Paris and other major European cities, there is a recommendation to purchase further equipment for MPS firearms officers in order to effectively response to changing threat levels and scenarios.

This equipment will be used to support the increase in firearms officers announced by the MPS Commissioner and increase the capability of the current armed response teams.

At time of writing, the threat level in London remains at 'Severe'. The equipment mentioned in this decision is required as soon as possible in order to increase current capability and the threat level supports this need, hence the decision for Single Tender Action.

Armed Response Vehicles and Counter Terrorism Specialist Firearms Officers will be allocated this equipment and are trained to respond using the most recent attack methodology intelligence.

All equipment has been assessed as suitable and tested by the users and viewed as best placed to respond to emerging threat levels and attack methodologies.

#### Recommendation:

The DMPC is asked to agree to the procurement, via Single Tender Action, of an increase in equipment for firearms officers totalling £11,284,088.87
