1 Introduction and background

1.1 DMPC has received a request from DLS seeking approval to settle the claim identified in the exempt part of this report.

2 Issues for consideration

- 2.1 The claim is for false imprisonment and assault and the physical and psychiatric injuries sustained in the incident.
- 2.2 One officer involved in this incident has been dismissed for discreditable conduct. One other officer is currently facing gross misconduct proceedings.

3.1 The cost will be paid by DLS against a MPS delegated budget
