Pursuant to paragraph 34 of Schedule 23 to the Greater London Authority Act 1999, the Mayor issues the following supplementary paragraphs to the guidance which was previously issued in 2007. TfL shall have regard to the guidance as supplemented with the paragraphs below:

To be inserted after paragraph 9:

10 Draft major variation order pending revision of the mayor's transport strategy

- 10.1 Where TfL wishes to propose a major variation to a road user charging scheme which would not yet be in conformity with the current version of the Mayor's Transport Strategy (MTS), TfL may prepare a draft major variation order and publicise its intention to make it pending revision of the MTS.
- 10.2 In the circumstances set out in 10.1, the Mayor expects TfL to have regard to the guidance that applies in respect of the making and publicising of a major variation order as set out in paragraphs 4.2 and 4.3 save that the notice to be published and any other publicity shall instead refer to TfL's intention to make a major variation order pending revision of the MTS. The contents of the notice to be published under paragraph 4.2 shall include all of the information specified in paragraph 4.4 except that the information shall be given in respect of the draft major variation order which is in the same form as the major variation order that TfL intends to make. In addition, TfL shall state in the notice that it is proposing to make a major variation order in the form of the draft major variation order subject to the MTS being revised. The Mayor expects TfL to make available the draft major variation order.
- 10.3 The duration of publicity for the purposes of paragraph 4.5 shall be calculated from the date on which TfL publishes notice of its intention to make a major variation order.
- 10.4 The draft major variation order shall be in the form set out in Appendix A to this guidance with appropriate amendments made to indicate that it is a draft order and has not yet been made.
- 10.5 The documents to be submitted to the Mayor in accordance with paragraph 4.8 shall include the draft major variation order rather than the made major variation order.
- 10.6 Following publication of the revised MTS, TfL may then make the major variation order which shall be in materially the same form as the draft major variation order which has been publicised in accordance with paragraphs 10.1 to 10.3.
- 10.7 Where TfL has previously publicised its intention to make a major variation order and has had regard to paragraphs 10.1 to 10.5, the Mayor does not expect TfL to publish a separate notice that it has made a major variation order which is in materially the same form as the draft major variation order. Nor does the Mayor expect TfL to undertake any of the other activities which ordinarily follow from the making of a major variation order as set out in paragraphs 4.2 4.8. Instead, TfL may submit the made order to the Mayor for confirmation. Paragraph 4.9 shall then apply as modified by paragraph 10.3.
- 10.8 Following the Mayor's confirmation of the major variation order, TfL may have regard to the publicity expectations set out in paragraphs 4.10 to 4.12. In addition to the matters set out in paragraph 4.12, the notice which TfL is expected to publish should

state that TfL has previously indicated its intention to make the major variation order and when the order was made.
