DELEGATION TO TRANSPORT FOR LONDON IN RESPECT OF
WORLD CAR FREE DAY 2020

Background

1. World Car Free Day 2020 is to be held on 20 September 2020 and is an event that will promote walking, cycling, improvements to air quality and a reduction in car use, in line with the Mayor's Transport Strategy and London Environment Strategy. The event will be held in central London in a footprint that includes iconic landmarks such as Tower Bridge.
2. Transport for London (TfL) works with various delivery partners and/or stakeholders in relation to the delivery of a number of road events and connected initiatives. These may involve TfL undertaking a number of potential activities on the Transport for London Road Network (TLRN) and on other roads that exceed its statutory functions as a highways, traffic and/or street works authority under relevant applicable legislation. The purpose of this Delegation is to enable TfL to undertake all and any aspects required in order to successfully stage World Car Free Day 2020 and thereby to further one or more of the following purposes: furthering the promotion of economic development, wealth creation and social development in Greater London or furthering the promotion of the environment in Greater London.


Delegation

3. Accordingly, under section 38(1) of the Greater London Authority Act 1999 as amended ("the GLA Act") I authorise TfL to exercise the GLA's functions under sections 30 and 34(1) of the Greater London Authority Act 1999 to do anything that TfL considers necessary or expedient for the purposes of co-ordinating, supporting, preparing, staging and delivering all or any aspects of the World Car Free Day 2020 and associated events.
4. The powers conferred by this Delegation are supplemental and without prejudice to any power or functions TfL otherwise has under any relevant legislation, and in particular in its capacity as a highway, traffic and/or streets authority in Greater London.

Conditions

5. The authorisation conferred by paragraph 2 above is made subject to the following conditions:
 - a. The activities carried out by or on behalf of TfL in implementing the delegation will be the subject of regular reports and advice to me on progress and developments;
 - b. In implementing this delegation TfL will comply with any instructions or guidance issued by me or any officer I nominate;
 - c. In devising / bidding, planning and delivery of World Car Free Day 2020 and associated events, TfL will work with the GLA's Events Manager to ensure that my interests, views and objectives are represented at all stages of the event process.
 - d. No costs incurred in the implementation of this Delegation shall be borne by the GLA; and
 - e. TfL shall at all times afford the member of staff designated from time to time as the GLA's Monitoring Officer all reasonable co-operation and access to documents and facilities as may be required from time to time in respect of that person's duties as Monitoring Officer under section 5(2) of the Local Government and Housing Act 1989 (as substituted by section 73(6) of the GLA Act).
