Thank you for your request for information which the GLA received on 1 April 2019. Your request has been dealt with under the Freedom of Information Act 2000.

You asked for;

Breakdown of housing for "Kingston Town Centre Network" by

1. Proportion of houses and ii. proportion of flats as of the dates of publication of the following documents:

a. the 2001 Census and as derived from the Census

b. the London Plan 2004

c. The London Plan 2008

d. The London Plan 2011

e. Further Alterations to the London Plan 2015

f. draft London Plan 2016

2. Please can you provide information showing the area covered by the "Kingston Town Centre Network" for each of the dates a. to f. above.

3. Please can you send me the PTAL rating for Kingston Town Centre Network as of each of the dates a. to f. above

Our response to your request is as follows:

1. The breakdown of houses and flats for the census output areas that fall either fully or partially within the Kingston town centre boundary are included in the spreadsheet 'Kingston Town Centre 2001 Census extract'. Residential completions within the Kingston town centre boundary since 2001 are listed in the spreadsheet 'Residential completions in Kingston town centre'. Column L identifies whether the completed units are houses or flats and the completion date is in column S so the change over time can be calculated. The 'FY' period in column T runs from 1st April to 31st March the following year, so FY16 runs from 1st April 2016 to 31st March 2017. This data was extracted from the London Development Database. The image file 'Kingston town centre with output areas' shows the town centre boundary and the census output areas, as well as the location of the residential completions within the town centre boundary.

2. The town centre boundaries that make up the town centre network are defined by the relevant local authority. In this case, the Kingston town centre is defined in the Area Action Plan (AAP) which can be found on Kingston's website at https://www.kingston.gov.uk/downloads/download/43/kingston_town_centre_area_action_plan. The Mayor does not keep records of changes to the boundary over time, but it is assumed that the AAP boundary will not have changed since it was adopted in 2008.
3. PTAL maps are produced and updated by Transport for London to a timetable that is not linked to the publication of the London Plan. Using the information that we have available, we have produced maps of the town centre boundary with the PTALs from 2005, 2008, 2012 and 2015. 2015 is the last year the PTAL map was updated.
