Thank you for your request for information which the GLA received on 26 April 2017. Your request has been dealt with under the Freedom of Information Act 2000.

You have asked whether the people listed in Appendix 1 of the Garden Bridge Review who contributed orally to the review;

- a) recorded audio/video for the interviews;*
- b) produced transcripts or write-ups for these interviews?*

In response, no visual recordings were made.

With regards to audio, not all of the meetings listed in Appendix 1 of the Garden Bridge Review were recorded due to the unavailability of a Dictaphone, in those particular instances no transcript was possible. Where the meeting was recorded, in the majority of cases a transcript of the meeting was written up.

The list of witnesses in Appendix 1 is not indicative of individual meetings, audio recordings and transcripts because a number of guests spoke to Dame Margaret in group discussions.
