The MPS has an obligation to ensure that all steps are taken to minimise the need for officers to resort to potentially lethal force. This obligation is particularly relevant in the context of armed policing.

Conflict management dogs are trained to provide additional tactical options for Specialist Firearms Officers, particularly when dealing with violent subjects in armed operations, including counter-terrorism operations.

The deployment and use of a CMD is a less lethal option which is likely to reduce the need to resort to other force, including the use of firearms by police officers. The use of CMDs may significantly reduce the risk to police officers and the public.

CMDs are already in use in the MPS. This proposal is to expand the capacity that the MPS already has in order to maximise the availability of this tactic as a less-lethal option.

Recommendation:

The Deputy Mayor for Policing and Crime is recommended to:

- Approve the MPS Conflict Management Dogs capability to increase;
- Note that the MPS will now proceed to delivery and go live (Stage Gate 4).
- Approve capital spend of £1.117m in 2019/20, and revenue spend of £0.053m for the delivery of the project, to be funded from project revenue budgets.

EXECUTIVE SUMMARY

Following the successful completion of the Conflict Management Dogs (CMD) pilot in 2018, this outline business case requests approval to progress to delivery (removing Stage Gate 3) of the CMD project.

Recommendations

The Deputy Mayor for Policing and Crime, via the Investment Advisory Board (IAB), is asked to:

- 1. Agree the minimal viable option, approving the MPS Conflict Management Dogs capability to increase;
- 2. Approve this project to not return to PIB & IAB, removing Stage Gate 3 and to proceed to delivery and go live (Stage Gate 4).
- 3. Approve capital spend of £1.117m in 2019/20, and revenue spend of £0.053m for the delivery of the project, to be funded from project revenue budgets.

There are additional decisions requested which have been removed due to operational confidentiality.
