Thank you for your email of 24th Of July 2015 to the Mayor. As the GLA's Area Manager for the London Borough of Ealing I have been asked to respond to your request.

In your email you mention "home and community funding". You are correct that the Homes and Communities Agencies (HCA) Affordable Housing Programme (AHP) have been devolved to the Mayor. For information about housing delivery outputs please see attached table detailing the AHP funding provided by the Greater London Authority for the South Acton Estate in Ealing since 2011. Please note this only relates to the programmes directly funded by the Mayor and to those specific programmes that were devolved from the Homes and Communities Agency to the Mayor.

There are other potential future funding programmes, not controlled by the Mayor, for example the Estates Regeneration Fund. This is a national programme administered by the Homes and Communities Agency.
