Thank you for your request for your further correspondence relating to the ADUP 2 framework. You asked:

Have I read it correctly that you've given us here the winners of contracts awarded by the GLA and/or TFL but not the winners of the deals handed out through the same framework but by other clients/bodies?

Can you confirm my reading of the situation and if it's correct please can you provide the names of the other winners - every single project handed out through this framework please - or provide details for people who can?

Our response to your request is as follows:

Your reading of the previous information issued to you on ADUP framework usage is correct in that it related only to usage by the GLA and TfL.

Please find below containing the additional information you are seeking. Please note that the information recorded here is based only on instances where public sector organisations have engaged with the ADUP Panel Manager to confirm details of their procurement processes. Further, this information does not reflect procurement processes that are currently 'live', either in mini competition, evaluation or standstill, or those that have been temporarily put on hold mid-procurement

Whilst we request that public sector organisations supply us with information on the contracts they have let under the ADUP framework, the recording of data relating to ADUP usage by public sector organisations external to the GLA Group is an ongoing process; it is therefore not always possible to hold a full set of information at any one time.
