Thank you for your request for information which the GLA received on 05<sup>th</sup> February 2021. Your request has been dealt with under the Freedom of Information Act 2000.

Please find below the information we hold within the scope of your request about the 'Everyone In' support scheme for rough sleepers during the Covid-19 pandemic.

- 1. Based on the data you have already provided for the Government dataset 'Coronavirus (COVID-19) emergency accommodation survey data: November 2020' (which can be found here:
  - https://www.gov.uk/government/publications/coronavirus-covid-19emergency-accommodation-survey-data-november-2020), how many of the total number of people listed as 'currently being provided with emergency accommodation in response to Covid-19 pandemic' in your local authority district (see Table 1) were;
    - a. Funded solely by the Ministry of Housing, Communities & Local Government's 'Everyone In' scheme
    - b. Funded directly by the local authority because they had 'No Recourse to Public Funds' conditions attached to their immigration status
    - c. Funded directly by the local authority for another reason (please specify)
    - d. Funded by a source other than the Ministry of Housing, Communities & Local Government or the local authority (please specify)

We are not be able to provide the information requested on numbers of people funded solely or directly by a specific funding stream as we do not have this information. - a. How many people are currently being provided with emergency accommodation in response to the Covid-19 pandemic in your local authority district
- Of those people currently being provided with emergency accommodation, how many have 'No Recourse to Public Funds' conditions attached to their immigration status
- c. How many people have been moved into settled accommodation or a rough sleeping pathway outside of temporary accommodation since the Covid-19 response began in your local authority district

d. Of those people who have been moved into settled accommodation or a rough sleeping pathway outside of temporary accommodation, how many have 'No Recourse to Public Funds' conditions attached to their immigration status.

Please find below the information which we have identified as within scope of your request. This information is taken from the Combined Homelessness and Information Network (CHAIN) database, which is commissioned by the Mayor, provided by St Mungo's and has been used by support providers in commissioned hotels. The data below relates only to those accommodated in GLA commissioned Covid-19 hotels and does not include those accommodated in the Severe Weather Emergency Protocol (SWEP) hotels.

- a. How many people are currently being provided with emergency accommodation in response to the Covid-19 pandemic in your local authority district
  - As of 28 January 2021, there are 884 people being provided accommodation in GLA Covid-19 hotels (this is excluding SWEP hotels)
- b. Of those people currently being provided with emergency accommodation, how many have 'No Recourse to Public Funds' conditions attached to their immigration status
  - Nobody has been recorded specifically as having a 'No Recourse to Public Funds' condition attached to the immigration status, understood as someone with limited leave to remain but with an NRPF condition attached to their leave. However, 550 people have been recorded as having no, not known or not recorded recourse to public funds. Please note that all those in GLA hotels are offered immigration advice and support to clarify or obtain entitlements to public funds. The current recourse to public funds field on CHAIN does not allow for nuanced recording of the differing situations of non-EEA nationals with no recourse, and EEA nationals who cannot currently access benefits. As a result, users may have used this field with differing interpretations of what the options mean, and the information should be treated with caution. We have been planning to introduce changes to facilitate more accurate recording, but this has not yet been achieved due to the high volume of work arising from the Rough Sleeping Initiative, and latterly Covid-19 emergency response.
- c. How many people have been moved into settled accommodation or a rough sleeping pathway outside of temporary accommodation since the Covid-19 response began in your local authority district

Since March 2020, 796 people have positively moved on from the hotels, please see below the breakdown.

Please note that, due to the emergency nature of the situation, hotel staff were not recording outcomes in the initial phase of the service. As a result, it is likely that there may be some people who left hotels with a positive outcome which is not reflected in these figures. Accommodation outcomes specifically relate to accommodation in the UK, and in many cases may also constitute a reconnection. Where a reconnection has been recorded without an accommodation outcome, it is likely this will represent a reconnection outside the UK.

d. Of those people who have been moved into settled accommodation or a rough sleeping pathway outside of temporary accommodation, how many have 'No Recourse to Public Funds' conditions attached to their immigration status.

Of those who moved-on positively from the hotels since March 2020, nobody was recorded specifically as having a 'No Recourse to Public Funds' condition attached to the immigration status, understood as someone with limited leave to remain but with an NRPF condition attached to their leave, for the reasons set out in response to question 3b. However, 283 people had been recorded as having no, not known or not recorded recourse to public funds.
