# **Decision required - supporting report**

# 1 Introduction and background

- 1.1 MOPAC has received a request from DLS seeking approval to settle the claims identified in the exempt part of this report.
- 1.2 The settlement claims relate to two of three potential claimants in a connected civil claim. Please see the exempt report for further details.
- 1.3 A claim form will be served by 26 September following authorisation from MOPAC.

#### 2 Issues for consideration

- 2.1 The first claimant (Officer 2) seeks damages for loss of earnings/overtime, stress and depression caused by a lengthy misconduct investigation.
- 2.2 The second claimant (Officer 3) seeks damages for stress and depression caused by a lengthy misconduct investigation.
- 2.3 More detail on the background to this case and potential liabilities are outlined in Part 2 of this report.

#### 3 Financial Comments

3.1 The proposed cost of the settlement can be met from within the DLS against a MPS delegated budget.

# 4 Legal Comments

- 4.1 Pursuant to the MOPAC Scheme of Delegation dated September 2013, The DMPC must authorise the settlement because it fulfils the criteria set out in section 5.7 of the Scheme including the financial level.
