Thank you for your request for information which the GLA received on 11 October 2019. Your request has been dealt with under the Freedom of Information Act 2000.

You asked for:

Can I request to see the Mayor's communications with the British bus manufacturers Alexander Dennis, Optare & Wrightbus between the years from 2008 till 2016 when Boris Johnson was Mayor of London.

Our response to your request is as follows:

Please find attached the information we hold within scope of your request. Please note that off topic information relating to personal matters and the names of some members of staff are exempt from disclosure under s.40 (Personal information) of the Freedom of Information Act. This information identifies specific employees and as such constitutes as personal data which is defined by Article 4(1) of the General Data Protection Regulation (GDPR) to mean any information relating to an identified or identifiable living individual. It is considered that disclosure of this information would contravene the first data protection principle under Article 5(1) of GDPR which states that Personal data must be processed lawfully, fairly and in a transparent manner in relation to the data subject.

Please note that we hold two further items of correspondence with Wrightbus, we believe that the information you have requested falls under the exemption for Commercial interests at section 43(2) of the Act, which is subject to a public interest test.

The Freedom of Information Act (ss.10(3) and 17(2)) allows public authorities to extend the period for responding to requests under the Act if the information requested is subject to exemptions and longer is needed to consider the public interest. I am writing to inform you that it will be necessary to extend the time limit to respond to your request beyond 20 working days in this case. We expect to have made a decision on this matter by 6 December 2019, though if we are able to make a decision before then, we will contact you sooner.

Thank you for your letter of 23 March 2015. I wanted to write to thank you for meeting with me on 25 February to discuss my future plans for ultra low emission buses in London. I found our discussion extremely helpful and am much encouraged that you share my aspirations to increase dramatically the number of ultra low emission buses in London, including zero emission buses like electric and hydrogen fuel-cell vehicles. As you are no doubt aware, this is an issue with strong cross-party support within the Assembly as well. I was also pleased that you supported improving the design of buses used in London and incorporating New Routemaster DNA in your future designs to create a more clearly recognisable and consistent family of bus models.

In addition to thanking you for attending, I am writing to update you on developments since we met and to set out next steps for taking forward our discussion.

As you may have heard, on Thursday 26 March 2015 I confirmed the introduction of the Ultra Low Emission Zone in 2020. In addition to requiring cars, vans, coaches, private hire vehicles and lorries to meet new emission standards, I have also committed TfL to ensuring that by 2020 all double deck buses operating in central London will be hybrid and meet the Euro VI standard (with the exception of the 300 existing New Routemasters) and that all single deck buses will be zero emission at tailpipe (i.e. electric or hydrogen fuel cell).

As I set out when we met, this will require continued reductions in the capital premium TfL currently pays as well as improvements in the lifetime operating costs of these vehicles compared to conventional diesel buses. I understand you recently met with Leon Daniels, Managing Director of Surface Transport, and Mike Weston, Director of Buses, to discuss TfL's relationship with you going forward. I hope this conversation was fruitful.

Just as one example, TfL have already accepted a tender to convert the entire 312 bus route to electric buses. I want to build on this achievement as soon as possible and believe that routes 507 and 512, which are now out to tender, are excellent candidates to be entirely operated using electric buses. I would encourage you to work with bus operators so that they can bid on this basis.

Finally, since we met, the C40 Cities Climate Leadership Group has launched its Clean Bus Declaration at the Conference of Latin American Mayors in Buenos Aires. So far, 20 cities have signed the declaration with more expected to join shortly, underlining the global commitment to reducing emissions from our bus fleets. These cities have committed to purchasing 40,000 ultra low emission buses (e.g. hybrid, electric and hydrogen) by 2020. This equates to around 30 per cent of their total bus fleets.

Meeting to discuss future plans for ultra-low emission buses in London

Thank you for accepting my invitation to attend a joint meeting with myself and other major bus manufacturers serving the London market. I am now writing with further details about what we will be discussing as well as information on logistical arrangements.

The meeting will be held in my office at City Hall, The Queen's Walk, More London, London SE1 2AA at 15:00 on Wednesday 25 February. This meeting will be followed by a separate briefing by Kevin Austin, Director of Initiatives, Regions, and Events at the C40 Cities Climate Leadership Group on a new global clean bus declaration and proposals for a London summit in summer 2015. I expect both meetings to last no longer than an hour and a half. To keep the meeting focused I regret that each company can only send one representative and this must be at a suitably senior level (i.e. Chief Executive or Managing Director).

As you know, improving air quality and tackling climate change have been priorities for me since I was elected. Over the past seven years, I have presided over Europe's largest fleet roll out of hybrid buses, including our ground-breaking New Routemaster, as well as promoted early adoption of all-electric and hydrogen fuel-cell buses. I want to quickly reach the point where all buses entering the Transport for London (TfL) bus fleet are ultra-low emission, but this switch will only occur in the volumes required if more cost-effective and sustainable options become available — an acceleration point which has proved frustratingly elusive to reach to date. Consequently, I would like to discuss my aspirations in more detail with you and how we can work together to make these a reality.

In my discussions with Mayors of other world cities, it has become clear that they share my aspirations and concerns about current capital premiums for ultra-low emission buses. Increasingly, we expect ultra-low emission buses to become the standard vehicle for all our fleets. We are keen to address the barriers to this once and for all to unlock the true potential of new technologies that best tackle the environmental problems our cities face. Working through C40, cities across the world are signing up to a new Global Declaration for Clean Buses that will be announced at an event in Buenos Aires in March. Following this, I am keen to host a London summit this summer to discuss the relevant issues with manufacturers, leasing companies, public transport operators, multi-lateral development banks and other funding agencies. I have asked C40 to provide a short briefing after we have met to set this out in more detail and explain the next steps for the London summit. Working together, I believe we can unlock a significant and exciting market opportunity for bus manufacturers.

I hope you find this of interest and I am looking forward to meeting you on 25 February. In the meantime, should you have any questions, please feel free to contact many my Air Quality Manager, on @london.gov.uk.

Meeting to discuss future plans for ultra low emission buses in London

Thank you for meeting with me on 25 February to discuss my future plans for ultra low emission buses in London. I found our discussion extremely helpful and am much encouraged that you share my aspirations to increase dramatically the number of ultra low emission buses in London, including zero emission buses like electric and hydrogen fuel-cell vehicles. As you are no doubt aware, this is an issue with strong cross-party support within the Assembly as well. I was also pleased that you supported improving the design of buses used in London and incorporating New Routemaster DNA in your future designs to create a more clearly recognisable and consistent family of bus models.

In addition to thanking you for attending, I am writing to update you on developments since we met and to set out next steps for taking forward our discussion.

As you may have heard, on Thursday 26 March 2015 I confirmed the introduction of the Ultra Low Emission Zone in 2020. In addition to requiring cars, vans, coaches, private hire vehicles and lorries to meet new emission standards, I have also committed TfL to ensuring that by 2020 all double deck buses operating in central London will be hybrid and meet the Euro VI standard (with the exception of the 300 existing New Routemasters) and that all single deck buses will be zero emission at tailpipe (i.e. electric or hydrogen fuel cell).

As I set out when we met, this will require continued reductions in the capital premium TfL currently pays as well as improvements in the lifetime operating costs of these vehicles compared to conventional diesel buses. Mike Weston, Director of Buses at TfL will be meeting with each of you to explore what further action will be taken to help achieve this.

Just as one example, TfL have already accepted a tender to convert the entire 312 bus route to electric buses. I want to build on this achievement as soon as possible and believe that routes 507 and 512, which are now out to tender, are excellent candidates to be entirely operated using electric buses. I would encourage you to work with bus operators so that they can bid on this basis.

Finally, since we met, the C40 Cities Climate Leadership Group has launched its Clean Bus Declaration at the Conference of Latin American Mayors in Buenos Aires. So far, 20 cities have signed the declaration with more expected to join shortly, underlining the global commitment to reducing emissions from our bus fleets. These cities have committed to purchasing 40,000 ultra low emission buses (e.g. hybrid, electric and hydrogen) by 2020. This equates to around 30 per cent of their total bus fleets.

As you know, I am keen to hold a follow up summit in London on 29 June 2015. I enclose the presentation that Kevin Austin, Director of Initiatives at C40, gave to you in the session following our meeting. He would welcome any comments you may have on this to


Re: Ultra-Low Emission Routemasters for London

Thank you for inviting me to the joint meeting with yourself, your officials and other bus manufacturers on 25 February 2015. Wrightbus has given everything that was discussed very serious consideration, and we would like to respond with a proposal which we believe will address your objectives.

You made it clear at our meeting that you wished quickly to reach a point where all buses entering the TfL fleet are ultra-low emission, and that they should be both cost effective and sustainable, and of course should continue to incorporate the New Routemaster "DNA" into the fleet. You will be aware that under the terms of the existing contract between TfL and Wrightbus you have the option to order up to 200 further vehicles before the Routemaster design can effectively be shared with other manufacturers. We believe that we can build on the success of the project to date and use the next phase to deliver a bus which offers a significant improvement in emissions and air quality, is more versatile in operation, and delivers even better value for money.

We have talked to TfL about the operational requirement for buses going forwards, and it is clear that the fleet cannot make effective use of further 3 door buses at the existing 11.3M length. Therefore to offer improved manoeuvrability and to allow the vehicle to be used more widely, we propose a shorter (10.6M) variant with 2 and 3 door options available, which we think will cover all the bases whilst retaining the superb New Routemaster identity.

More importantly perhaps, we would propose that the next 200 buses have ultra-low emission status through the incorporation of a range-extending EV (Electric Vehicle) driveline. This driveline is a planned evolution of the existing Routemaster components, with the addition of external conductive

charging to be carried out at either the bus depot or terminus. The effect of this new system is to allow for the opportunity charging of the batteries at different times during the day, thereby reducing the consumption of fuel and at the same time lowering emissions. We can provide the projected data to TfL for their analysis, but we are very confident that the range extending EV driveline will significantly improve air quality and emissions.

I attach for your consideration outline drawings of both options for an ultra-low emission Routemaster. Since the changes to the existing vehicle will be relatively small, and do not impact the appearance of the bus other than its length, we are very confident of producing the first ultra-low emission New Routemaster by the end of 2015, with the ability to produce the first vehicles for service in the first quarter of 2016.

When we last met you challenged the industry to look at the capital premiums for ultra-low emission buses, and I believe that our proposal also addresses that aim. We have also consulted with a new funding agency and again this is an element of the proposal we will be happy to discuss with TfL in more detail.

I am aware that you recently met with Rt Hon Ian Paisley Jnr MP, and I know that he was delighted to receive the Honorary Freedom of the City of London. I understand that he raised the subject of the potential for exercising the option to purchase 200 more Routemasters, and I daresay he will have emphasised the economic importance of this order to Northern Ireland, and indeed to the supply chain throughout the United Kingdom. The Routemaster project has been transformational for Wrightbus and has become a beacon within the industry for innovation and manufacturing excellence. I do hope that the New Routemaster will now lead the way into the ultra-low emission zone.

I will be happy to elaborate on this proposal at any time, and look forward to hearing from you soon.
