Thank you for your request for information regarding the ULEZ consultations undertaken so far. Your request has been dealt with under the Freedom of Information Act 2000.

Our response to your request is as follows;

1. *How many respondents have there been to the ULEZ consultations undertaken so far (current open ones excluded)?*
 - Original consultation on the Ultra Low Emission Zone (27 October 2014 – 9 January 2015) - **16,281 responses** to the consultation were received from the public and businesses
 - Consultation on updated Ultra Low Emission Zone proposals for taxis and Private Hire Vehicle licensing (1 July 2015 – 25 August 2015) - **516 responses** to the consultation were received from public and businesses
 - Consultation on a new Emissions Surcharge and ideas for improving Ultra Low Emission Zone (10 October 2016 – 18 December 2016) - **15,480 responses** to the consultation were received from the public and businesses
 - Consultation on changes to the central London Ultra Low Emission Zone (4 April 2017 – 25 June 2017) - **18,126 responses** to the consultation were received from the public and businesses.
2. *Where have the existence of the consultations been advertised, including current open ones?*
3. *What methods of responding to the consultations are available?*
4. *Which groups have been consulted in drawing up the proposals?*

The GLA does not hold information relating to how the current consultation is being advertised.
