Title: **Modern Slavery Programmes S22a Agreement** 

## **Executive Summary:**

In September 2016, Devon and Cornwall Chief Constable Shaun Sawyer and the NPCC Lead for Modern Slavery (MS), and his team successfully bid into the Police Transformation Fund to support the introduction of a number of projects to improve the national policing response to MS. Police and Crime Commissioners have agreed to collaborate in relation to the running of the Modern Slavery Police Transformation Programme.

Additional funding has now been confirmed which allows the programme to be extended until March 2020. In order for the Programme to be run successfully and extended until March 2020, a collaboration agreement under S22a of the Police Act 1996 is required.

The paper therefore requests approval for collaboration with the Police and Crime Commissioner for Devon and Cornwall under the updated S22a agreement for the programme to continue running the Modern Slavery police transformation programme in order to continue the formalised policing approach in England and Wales.

## Recommendation:

The Deputy Mayor for Policing and Crime is recommended to approve a collaboration with the Police and Crime Commissioner for Devon and Cornwall, under the updated S22 of the Police Act 1996.

#### PART I - NON-CONFIDENTIAL FACTS AND ADVICE TO THE DMPC

## 1. Introduction and background

- 1.1. In September 2016 Devon and Cornwall, successfully bid to the Home Office for funding through the Police Transformation Fund to ensure that police and partners reduce the vulnerability, threat and risk surrounding MS criminal activity, establishing nationally coordinated action, assessment, guidance and training.
- 1.2. The Programme has been developed and this collaboration agreement is being entered into as a direct response to the recommendations to the police made within the Home Office 2016 Review of the Modern Slavery Act, HMICFRS 2017 Thematic Inspection of Modern Slavery and to support forces to respond to the 2019 Independent Review of the Modern Slavery Act
- 1.3. The purpose of this Agreement is to create a national team for the Term, which shall be led by the Lead Force and which shall be responsible for supporting the NPCC Modern Slavery Lead to improve the policing response across England and Wales to Modern Slavery.
- 1.4. In November 2017, DMPC signed a collaboration agreement with the Police and Crime Commissioner for Devon and Cornwall, under S22 of the Police Act 1996.
- 1.5. A new SS2a collaboration agreement has been written for the programme for 2019-20.
- 1.6. The project objectives have been updated to reflect the progress made in understanding the threat the in the initial funding period (2016-2019) and to increase the emphasis on prevention work, support for victims and practical steps to increase the level of prosecutions.
- 1.7. Modern Slavery Police Transformation Programme 2019/20 is designed to provide the following key deliverables:
  - An increased focus on prevention, demand reduction and targeted intelligence development and interventions.
  - A continued focus on improving investigations, case file preparation, and overcoming barriers to prosecution.
  - Setting the foundation for closer working across child criminal exploitation, and child labour exploitation by fully exploring crossovers and minimising gaps in our response.
  - A clear exit strategy to ensure that the modern slavery work moves in to business as usual in 2020/21 following closure of the programme.

#### 2. Issues for consideration

2.1. The Agreement will be effective once the Lead Force and at least 75% of the remaining Parties have signed the agreement.

2.2. The purpose of the Agreement is that the Parties continue the national team to be led by the Lead Force and which shall be the responsibility of the NPCC Modern Slavery Lead to continue to improve policing response across England and Wales to Modern Slavery.

# 3. Financial Comments

3.1. The costs relating to this s22 collaboration agreement are funded by Devon and Cornwall as the lead force for this programme

# 4. Legal Comments

- 4.1. S22 of the Police Act 1996, as amended by Section 89 Police Reform and Social Responsibility Act 2011 allows the MOPAC, as the local policing body, in connection with the discharge of any its functions to enter into a collaboration agreement.
- 4.2. The MOPAC Scheme of Delegation at Clause 4.5 requires the Deputy Mayor for Policing and Crime to approve all collaboration agreements where the Act requires. As this is a policing body collaboration, it is required.
