RESPONSE

Thank you for your Freedom of Information request of 9 November to the Mayor's Office for Policing And Crime (MOPAC). I confirm that your request has been handled under the Freedom of Information Act 200 and that MOPAC does hold information relating to your request, as follows:

Regarding the 69 page booklet 'Draft Strategy for Consultation-July 2017

- Q.1 How many copies were printed?
- A.1 We made it clear that copies were available on request as soon as the consultation launched in July we are unable to determine the amount we printed off "in house" this way at MOPAC. 1000 copies were printed for external distribution, primarily for the events the MPS ran in each borough.
- Q.2 What was the cost of the printing?
- A.2 We are unable to determine the costs for the "on request" printing. The 1000 copies cost £3045+ VAT
- 0.3 On what date were the booklets distributed?
- A.3 Various dates. Copies were available on request as soon as the consultation launched in July. The majority of the booklets were distributed ahead of the MPS events. The MPS events started early Sept.
- Q.4 Where and by what means were they distributed?
- A.4 Where they were "on request" via the city hall post room. Additionally, they were sent to the front counters and to the events that the MPS held.

Regarding the tri-fold individual borough leaflets 'Changes to policing' Public consultation on changes to public access to the police- Autumn 2017

- Q.1 How many copies were printed?
- A.1 200 copies of each of the 32 leaflets. Total 6400.
- Q.2 What was the cost of the printing?
- A.2 £1797.60
- Q.3 On what date were the leaflets distributed?
- A.3 Various dates. Half of the leaflets were distributed to the MPS events. The MPS events started early September. The other half were sent to front counters in the relevant boroughs.
- Q.4 Where and by what means were they distributed?
- A.4 Various dates. These leaflets were intended as a hand out for the MPS events and for Neighbourhood Teams to distribute by hand to high foot fall points such as community centres and libraries, hence they were sent to front counters. They were sent via the MPS internal delivery system to the front counters and by courier to the events that the MPS held.
