## Introduction

In its March 2011 Report, *Just the Ticket: the ticketing arrangements for the London 2012 Olympic and Paralympic Games*, the Committee urged public bodies being given preferential access to tickets to take a lead and show restraint when bidding for tickets. The Committee also argued that there should be complete transparency and accountability for each ticket. Public bodies should publish a register stating what tickets have been purchased from LOCOG; to whom each ticket has been allocated and why; and how the cost of each ticket has been met. The Chair of the Committee wrote to the Government, Mayor, each London Borough and the City of London asking for details of what tickets each body was purchasing, if any, to whom they would be allocated, how they would be paid for, and whether details would be published.

This document sets out the positions of each public body, where known, and publishes responses received. Six London boroughs did not respond to the letter from the Chair of the Committee but did make the same information available in response to a Freedom of Information request from an individual. These responses have been made available to the Committee and are published here. Other boroughs, although not responding directly to the Committee, published their policies on Olympic tickets through other means.<sup>1</sup>

One London borough – Greenwich – did not respond to the Committee's report and does not appear to have yet made its position publically available through other means.

Thank you for your letter of 9 March enclosing a copy of the Economic Development, Culture, Sport and Tourism Committee's report 'Just the Ticket'.

I was pleased to read that the committee is supportive of LOCOG's ticketing plans which I agree strike the balance between raising the necessary funds and ensuring that tickets are affordable.

As you are already aware there are proposals for the GLA to receive, from LOCOG, a number (approx 450-500) of tickets to be allocated to external organisations and persons as part of a programme that seeks to drive investment and economic development in London. No one at the GLA is due to receive any of these tickets and no public money will be spent on them; instead sponsorship arrangements will be pursued to meet the costs. At the end of the Games I will publish details of who received each of these tickets, and why, on the GLA website.

Like you I believe that we must be transparent about the tickets that are received outside of the ballot process. I am happy to join you and your committee members in urging other public bodies to commit to publishing similar details of their own ticket allocation.

## Just the Ticket – The ticketing arrangements for the London 2012 Olympic & Paralympic Games

Thank you for your letter of 9 March 2011 regarding the ticketing arrangements for the Olympic & Paralympic Games.

LOCOG have offered the London Borough of Camden the opportunity to purchase up to 100 tickets for Olympic Games events. The offer of tickets was unsolicited by the borough; Camden has never lobbied or asked LOCOG to make any tickets available for the borough to purchase directly. The offer of tickets could be seen to go some way towards recognising the important ongoing role that the London boroughs are playing in the safe and successful delivery of the London 2012 Games.

However, we are in agreement with the Committee's proposals that the offer of tickets to public bodies is excessive. Camden will not be purchasing any of the 100 tickets offered by LOCOG to the 2012 Games events and ceremonies. In the current financial situation we do not think this would be an appropriate use of council resources, nor do we think it is the council's role to re-sell or re-distribute these tickets to the public or other organisations.

Camden believes it is important that as many tickets as possible are available to the general public at an affordable price. However, we do think it should be recognised through the ticketing arrangements that Londoners are making the largest contribution to the staging of the Games through their taxes. It would be our preference that the majority of tickets that have been offered directly to the London boroughs, the GLA and the Government were instead made available for residents of London boroughs to purchase. The ballot process developed by LOCOG will be open to the whole of the UK and EU countries and there is a risk that many Londoners will not get the opportunity to attend the events that are happening on their doorstep. We welcome LOCOG's commitment to make affordable tickets available for children and older people through the 'pay your age' scheme for those up to 16 years of age and £16 tickets for those over 60 years of age. Camden is also pleased to hear that LOCOG will be making the Games more accessible by providing some free tickets for the carers of disabled ticket-holders.

In addition we will be continuing to encourage all of Camden's schools to sign up to the Get Set Network to ensure as many of Camden's young people as possible get an opportunity to go to the Games through the 'Ticketshare' scheme. We're also encouraging our residents to be part of the Games through promoting and supporting both the official London 2012 volunteering schemes, through the Cultural Olympiad and through Camden's own legacy projects.

37 out of the 100 tickets allocation

(b) the total cost of the purchases,

## (c) to whom the Council intends to allocate the tickets,

Two of these tickets will be used by the Mayor and consort to attend the opening ceremony (at the lowest ticket price available of £150 each).

The remaining tickets will be allocated to some of the children in the Council's care. This reflects the fact that the London Olympics has as one of its main themes the objective of enthusing young people about sport. Where adults need to accompany them these will foster carers or youth workers.

Please note the Council is not able to offer the tickets available to it in any competition, auction or ballot under the rules imposed by LOCOG on their sale to us so we cannot for instance invite all residents to enter a draw.

## (d) whether a register will be published of how the cost of each ticket has been met.

The tickets will be paid for out of the Chief Executive's budget. It will be published on our website in our over £500 spend that is released each month.

You are free to use this information for your own use, including for non-commercial research purposes. It may also be used for the purposes of news reporting. Any other type of re-use, for example publishing the information, issuing copies to the public or marketing, will require our permission as copyright holder. If you intend to re-use this information in this manner you must apply to us.

The allocation of tickets has been a matter for the London Organising Committee of the Olympic & Paralympic Games.

Having read your report that 6.6 million tickets will be available to the public, a higher proportion than in other comparable events, is a fact to be welcomed and celebrated.

The suggestion that each London Authority receiving 100 tickets seems excessive is rather emotive language especially as your report does not place in context the resources that all London authorities are giving (without recharge) to ensure the success of the Games.

In respect of Southwark's position we do not know at this stage whether we will receive our proposed allocation. If and when we do we consider this information is administered in the same way that all Freedom of Information is managed.

Your report does not appear to acknowledge the strict restrictions around how these tickets are to be used.

Many of the tickets in Southwark will not be funded by the public purse but we do intend to ensure that young people and young people in care (for example, for whom we have corporate parent responsibilities) are able to attend.

Of course records will be kept.
