## **Freedom of Information request**

Thank you for your email of 6 January 2016 in which you requested the release of the following information under the Freedom of Information Act.

*"The total number of planning applications you received in each of the following calendar years: 2010, 2011, 2012, 2013, 2014, and 2015.*

*In each of the above years I would also like to know the following information:*

- The number of applications that were major developments and the number that were ordinary applications*
- The number of major development applications that received a formal decision within the statutory 13 week time limit*
- The proportion of major development applications that were initially rejected*
- The number of major development applications, including appeals, that took between 13 and 26 weeks to receive a final decision*
- The number of major development applications, including appeals, that took between 26 and 52 weeks to receive a final decision*
- The number of major development applications, including appeals, that took more than 52 weeks to receive to a final decision*
- The proportion of ordinary applications that received a formal decision within the statutory 8 week time limit.*
- The proportion of ordinary applications that were initially rejected*
- The proportion of ordinary applications, including appeals, that took between 8 and 26 weeks to receive a final decision*
- The proportion of ordinary applications, including appeals, that took between 26 and 52 weeks to receive a final decision*
- The proportion of ordinary applications, including appeals, that took more than 52 weeks to receive to a final decision*

The Mayor is consulted on all planning applications that are of potential strategic importance to London. However, as a statutory consultee, and not a determining authority, we do not hold information relevant to your request, which you will need to seek from each individual planning authority. - *I would also like to know the number of full time and part time staff, whether permanent or casual, who currently work in your planning department and how that number has changed each year from 2010.*

The following numbers are either permanent or fixed term contract staff and are taken as at April each year:

**2010** – 46 full time; 2 part time

**2011** – 44 full time; 3 part time

**2012** – 43 full time; 6 part time

**2013** – 44 full time; 5 part time

**2014** – 43 full time; 5 part time

**2015** – 49 full time; 5 part time

- *I would also like to know how many people working in your planning department have been formally disciplined or dismissed for misconduct since 2010, and in each case a summary of the reason”*

There was 1 dismissal in December 2012. We cannot release the reason for dismissal as this would lead to the identification of that individual. This information would therefore constitute personal data, as defined under the Data Protection Act.

This information is therefore exempt from release into the public domain under section 40(2) of the FoI Act as its disclosure in response to this request would constitute unfair and unlawful processing of that personal data, contravening the first Data Protection Principle of the Data Protection Act.
