Explanation of scoring process

First-round scoring

All applications to the Community Green Space Grants underwent a first-round assessment process, where they were scored on six criteria by two scorers from the GLA and Groundwork London. Applications that received an average score of over 60% and were therefore judged to have met a minimum quality bar, proceeded to a long list for review by the grants panel. The first-round scores for Project 68, Morecambe Community Garden Project, were as follows:

Final grants panel

At the grants panel, each project was reviewed by two scorers (different to the first round, including independent experts) who assigned an overall score out of four, and a recommendation: red (reject), amber (possible), green (fund). All applications were then reviewed by the whole grants panel and a decision agreed. The grants panel scores for Project 68: Morecambe Community Garden Project, were as follows:

The plot is the remains of the Congregational Chapel and garden where Robert Browning was baptized in the 18th century, social work initiated at the chapel eased the suffering of the poor and destitute of Walworth. Given ongoing regeneration of the Elephant and Castle we would like to value appropriately the heritage of the Browning Chapel by enhancing the open plot that remains. Riverside housing association, which owns the site, supports us, as do BOST and Southwark Council/Southwark Living Streets. The Friends of Nursery Row Park, who are submitting the application have extensive experience of involving the community in green spaces and we aim to create a pocket park with flowers and plants and space for sculpture displays, where all ages can sit and pass through.

4.3 Transforming London's environment

The Greener City Fund is focused on planting more trees and creating an accessible network of well-designed green spaces.

Answer:

This green regeneration project is needed because

- It is an area of precious green space near the Elephant and Castle, been part of the
 largest regeneration project in London in recent years surrounded by tall buildings. It is
 important to preserve the green areas we have. The site has no formal protection as
 open space (it is zoned as housing land) and is owned by a large Housing Association
 who support our project but do not have the local focus to manage the space to benefit
 the local community. That means the site is at risk of disappearing.
- It contributes to conserving the history of the area at a time of enormous change
 through regeneration: Morecambe Community Garden is all that is left of the site that
 was Robert Browning's 's Congregational Chapel. Walworth has a wonderful history
 and Morecambe community Park could be part of this legacy. A chance to encourage
 community in a green space and this would be a fitting memorial to Robert Browning's
 social concerns.
- It would give the community somewhere to meet the garden has high volumes of pedestrian traffic passing by but with nowhere to sit and rest.
- It is completely complementary with the current Walk Elephant project, which is a
 project led by Southwark Council and Living Streets to develop and enhance linkages
 between green spaces in Walworth and Bankside, including measures to provide

"wildlife corridors" between green spaces, as evidenced by our letter of support from Southwark Council.

Actions planned:

- The creation of the community garden will involve regrading of the space, selective
 pruning of mature trees to increase natural light, and creative new planting around
 spaces for temporary art exhibitions. New fruit trees and planting will be carried out
 with children from a local Primary School the Friends of Nursery Row Park have a
 long-running outdoor education project (two weekly classes) with a local primary
 school. There will also be space for yoga and dance.
- Maps showing the project designs are appended to this application

Meeting funding aims:

The space is currently well provided with mature trees but there is no ground level
planting at all – no colour or interest. That makes the site dark contributing to significant
underuse of the area. Our project will create a real green pocket park with a difference
– a place to rest but also bringing together art and nature. The project will, through
careful design and planting, turn this space into a well-used and loved green space.

Impacts:

- The project will be a fundamental and critical step in ensuring that the site remains green. Thus currently the site is effective as a small unpaved green space in reducing flood risk by permitting soaking up of rainwater; improving air and water quality through the impact of the trees and tree canopies (also providing shade). Fundamentally, the project will enhance biodiversity by planting plants that attract pollinators, turning what is currently a very un-diverse ecosystem at ground level (mown grass) into a haven for wildlife.
- Further, by involving the community and a local primary school in the design and planting, and providing community space for art and activities, the project is intended to foster and generate a new generation of champions of Morecambe Community Garden.

4.4 Making better places

We want to see projects that are part of a wider long-term effort to improve a place; where urban greening can make better, more imaginative use of spaces to benefit more people.

Answer:

We have designs for the space which are appended to this application.

Curently Morecambe Community Park is used mainly by dogs, who use the enclosed space as their toilet; there is nowhere for people sit and it is dark and unloved. It has a number of very positive aspects, however, which mean we are confident it can be a successful pocket park and community garden – this includes its location on a key pedestrian route (we have East Street market and the Walworth Road nearby; shoppers could rest before continuing to the market or from the market.) It also has several mature trees and a wonderful tomb (of Robert Holbert) dating from the 1800s. The land is owned by a housing association (Riverside) who also own the adjacent Asolando Drive housing – they have provided a letter of support for this project appended). The site is part of the former Browning Hall, named after Robert Browning who lived in Walworth.

The project will radically increase the usage and quality of the space. It is currently not a place you can linger – no seating and the grass is heavily soiled by dogs. If more members of the community could sit and enjoy the green surroundings it would be an immediate improvement to the area. To have flowers that show seasons in our urban environment would be exciting, to see nature rather than hard surfaces. Very close by there a lot of artists; Pullen's Yard and artists in Brandon Street and Morecambe Street have expressed interest in displaying sculpture and other art forms shown in the park would be very different for an urban space We have so many cultures in our area that could use the garden to celebrate community. A chance to exercise by dancing in an open space outside in your own neighborhood in central London is an opportunity not to be missed

Finally the project will provide opportunities for all activities identified above:

- Informal gathering; some seating and new planting and light will attract informal community activities and gathering, supported by inclusive design and ensuring that opportunities for antisocial behaviour are reduced.
- Active play; a flat space for dance and yoga
- Tranquil places to rest and enjoy nature; the garden is tranquil despite heavy
 pedestrian traffic on Browning Street on a key walking route between Walworth
 Road and East Street and the Browning and Rodney housing estates.
- Encouraging more walking and cycling? The garden is not big enough to generate
 walking and cycling within the space itself, but by being adjacent to major
 pedestrian and cycle route desire lines for travel it will make walking and cycling
 more attractive through providing an area to rest and reflect en-route.

Support:

and has thus an extensive network of local contacts within the local community. The project has been guided in development by Bankside Open Spaces Trust (BOST), is supported by Walk Elephant (Southwark Council and Southwark Living Streets) and Riverside Housing Association. It is also supported by local park Friends' group, the Friends of Nursery Row Park who have been active locally in community-led protection and management of green space for over ten years. Nursery Row Park is 200metres from Morecambe Community Garden.

Impact on local and wider community: The local area is undergoing great change - the regeneration of the Elephant and Castle has meant a great deal of churn in the local population. We believe that this makes the project particularly important - during periods of great change in population, it is vital to provide enhanced opportunities for community cohesion and support for linkages between new and existing residents and businesses. For example. as an artist living near East Street market has been an inspiration, for exhibitions at the Barbican 'Urban Walk' and Lethaby Gallery in Holborn 'The Pleasure of seeing you 'her works have shown the changing local population and getting to know neighbors has been a celebration for her working life. To now work on Morecambe Community Park enhancing what is left of the Robert Browning's Congregational Chapel is exciting. A green space to support the community, schools and pensioners in the neighborhood who have so much to offer each other. Making an area where these groups can meet creating community cohesion and wellbeing. Planting projects and Art exhibitions and Dance performances could be a feature in Morecambe Community garden

Opportunities for training and volunteering will be a core element of the implementation of the project – we have already identified our connection with a local primary school and we know from experience that the only way of developing a successful open space project is to involve the local community in design and implementation Once implemented, the park will offer opportunities not just for volunteering (Friends of Nursery Row Park have a successful track record of monthly gardening days and regular community events, and have a Green Flag award) but also for artists to present work. We estimate that 10 adults will actively be involved in the project, with 20+children from the local community/primary school. Once implemented, the volunteering opportunities will be greater, and we envisage around 200 hours of volunteer time per year at a minimum.

4.7 Leaving a positive legacy

Answer:

Our objective is to create a space that the community feels they own. By encouraging children from the schools and pensioners to help with the planting, there will be a sense of ownership that will grow. An open space to chat, have tea dances exhibitions somewhere the neighborhood will feel that they can use to have Tai Chi class because it will be a beautiful open space.

We will create projects to help maintain the space. Following the example of Nursery Row Park who have created a giant haystack in their park to maintain their wild flowers field which local children and Adults enjoyed, and have done this as a core element of the maintenance of the wildflower meadow, each year for the last ten years. We could clear the park to put up new art works or for a spring dance.

Crucial to the success of our plan is the support of Riverside Housing Association, the landowner. They currently maintain the garden at a basic level and are supporting our application – however the project will require enhanced maintenance input once established. Our plans envisage following the successful local examples of Victory Community Park and Nursery Row Park which both work with the landowner (in those cases, Southwark Council) to maintain specific elements of the parks through volunteer/community input. The local parks (these two plus Pasley Park Friends, Friends of Surrey Square Park and Friends of Salisbury Row Garden are all active in the local area of Walworth and work together (under the "Walwork Green Links" initiative) to share gardening equipment and expertise, providing a wider network of support and thus reducing future maintenance risks.

Ultimately the project will generate activity and interest and set the framework for the space to be significantly better used and loved, with structures to involve the community in decision making to generate ongoing community support in the long term.



Today the Green space between Morecambe Street and Asolando drive has been unloved for over twenty years. The great London Plains were cut to build a wall, to separate the car park from the green. The tomb of Richard Holbert from the cemetery has been placed in the park and this is the only evidence of this history in Walworth's.

There are local artists in the area that could create a sculpture garden; many historical and contemporary things could be incorporated into the design. 
