Untold Stories

- Round One of £1m fund launched 21 October
- Received 117 applications
 - 74 Grow and Make Happen larger grants
 - 45 Test and Nurture smaller grants
- Total of £1.8million has been requested
- Received applications for activity in 31 boroughs
- Many interesting and exciting projects
- Update on the Grow & Make Happen and Test & Nurture review panels
- Commissioners to be present on both panels alongside Shape Arts from the Partners Board
- Good spread of projects across London, able to showcase what the Commission is about
- Applicants will be informed beginning of April
- Launch event being planned Commissioners will be invited
- Need to review where the gaps are to target for the next round
- Round 2 will open in late Spring / early Summer 2022

Transatlantic Slave Trade memorial

Update on conversations to progress this project.

Discussion

- 1. How can we make sure it lives up to the values and principles the Commission has set out?
- 2. In achieving an exemplar of good practice what are the most important considerations for you?
- 3. Community engagement will be central what will success look like here?

Principles for Emblematic Projects:

- substantively change the narrative
- promote learning & engagement
- engender wider cohesion
- demonstrate sustainability
- represent a diversity of rigorous approaches
- educate and inform
- are specific in relating to their location
- enable grassroots representation

Other considerations:

- Permanent / Semi permanent
- Decentralised
- Representation of different perspectives via different medium
- Connect by values and principles
- Important to have broad outreach
- Look at contemporary aspects of slavery / indentured labour
- Community engagement must be from the outset
- Education element should be part of any memorial
- Potential for innovation
- Create era defining moment of change
- Galvanising moment for our work and public support
- London memorial (with possible national significance)
- Be uplifting, aspire and challenge
- How does it relate to what is happening today
- To be powerful, striking, and resonant

- Research some initial sites
- What are the sites of resonance in London
- Research in progress

Other emblematic projects

- Jasvir and Eleanor are on the Sikh War memorial group
- Jack is having a meeting with the London Aids HIV memorial team who are due to meet in April
- Feasibility study being drafted for "Seat of Honour" proposal

5) Commission Research

- Two pieces of research being conducted
- Urban Design London looking at boroughs widening representation in the public realm
- BAS Consultancy (Bristol report 2021) looking at how action is being taken on "contested" sites and heritage
- Some boroughs have not undertaken any audits or have found nothing significant
- All boroughs in pilot mode general lack of guidance and different processes
- Different teams lead the process for reviewing "contested" heritage
- Traffic light system in some boroughs
- Case Studies e.g., practicalities in changing names, unintended consequences
- Needs to be driven by good historical data

Commissioners requested a wider update across all of London's boroughs to consider how to support all to engage.
