1) Introduction and Welcome:

2) Commission Overview and Update:

Commission Research

- Urban Design London have been commissioned to speak with all London boroughs to identify policy and practice and any current programmes
- 14 boroughs have been interviewed to date
- 24 people / local authority colleagues attended a workshop on 17 January
- 12 local authority case studies have been collated
- Full report due Spring 2022

Untold Stories

- Round One of £1m fund launched 21 October
- Deadline for applications closed 12 January 2022
- Hosted 25 outreach sessions attended by over 500 people
- Held 50 individual consultations online with potential applicants
- Responded to 60 enquiry forms
- Received 117 applications
 - o 74 Grow and Make Happen Larger grants
 - 45 Test and Nurture smaller grants
- Total of £1.8million has been requested
- Received applications for activity in 31 boroughs
- Many interesting and exciting projects
- Assessors will review applications against a set of criteria, panel will determine spread across boroughs, beneficiaries reached, types of projects etc.
- Commissioners were asked to put themselves forward for the panel
- Next steps:
 - Applications are now being assessed
 - Applications will be moderated to check for consistency and fairness
 - Then will be submitted to a panel for recommendation for funding
 - Commissioners to express their interest to the team by Tuesday 15
 February if they would like to be on the assessment panel.
 - Panel meetings will be w/c 14 March 2022
 - Final sign off and announcements in April.
- Round 2 will open in late Spring / early Summer 2022

Engaging Londoners

- Commission has increased public engagement activities through Untold Stories grant programme
- Public engagement programming vital to delivering activity that Londoners can engage with throughout the year
- Team updated on the progress of developing further strands of activities to engage Londoners.
- Commissioners invited to help shape and be involved in the development stage of these programmes.

Discussion Topic 1: What makes heritage in the public realm 'contested'?

- Visible and missing
- Public education & meaningful engagement
- Whose voices and in what spaces?
- What might alternative phrases be inclusive history, evidence-based history?

Discussion Topic 2: What role (if any) can an initiative like the Commission for Diversity in the Public Realm play in addressing contested heritage in London?

- Listening to Londoners and gathering the evidence
- Helping to build communities of action
- Leading by example and building evidence base

Feedback & reflections

- Need for increased visibility and to reach a younger audience
- Acknowledging the work that came before
- Categorising what is/isn't contested
- Access and Participation identify where else are these conversations may be happening
- Schools gateway for explaining and new contributions
- Retain and explain we need to explain the full British history
- Ongoing annual exploration of discovery
- Create momentum for change
- More history not less

4) Emblematic Projects Framework

The Commission has set out a set of principles to consider for large scale public art and memorial projects for London.

Emblematic projects are those which:

- substantively change the narrative
- promote learning & engagement
- engender wider cohesion
- demonstrate sustainability
- represent a diversity of rigorous approaches
- educate and inform
- are specific in relating to their location
- enable grassroots representation

Other considerations:

- Historical narrative or representation needs to be evidence based
- Emblematic should stand for process to transform the way people engage with public realm.

- Memorials should also be future looking.
- Education element should be part of any memorial
- Engage a wide constituency not just from the community of interest but also beyond, for each project

London can learn from national and international examples. These include:

- Ottawa how the city is managing its commemorative landscape
- France and the research and work done on slaving ports
- New York memorial commission
