# **Background**

It advises the Chief Digital Officer on development and iteration of the Data for London platform; development of London's first Data Strategy and supports the efforts of GLA to create data services.

- 2) Presentation of the draft London Data Strategy

Theo Blackwell presented the draft London Data Strategy, including priorities and plans. The Board discussed the plans for platform development and how this was being implemented in parallel with the general programme activities.

Mary-Claire Walsh welcomed the members to the Advisory Board, commenting that the formation of the board was very positive for the Mayor's office as the need for data sharing is increasingly apparent (further highlighted by the pandemic).
