- 1.1 The Chair welcomed Members, officers and the public, both in the gallery and watching on the webcast, to the Mayor's Question Time meeting of the London Assembly.
- 1.2 Apologies for absence were received on behalf of Len Duvall AM and Sem Moema AM.
- 1.3 The Chair provided an update on recent Assembly activity, including: the Police and Crime Committee urging the Mayor to discuss the combat against online terrorism with tech companies; the Environment Committee requesting that the Mayor ensures London take advantage of opportunities presented by the historic COP26 meeting; the Health Committee requesting the Mayor to inform the Assembly of actions taken with Transport for London (TfL) to reinforce messaging around the wearing of face masks and the Chair's attendance at the London Youth Assembly which discussed issues key to young people, including education and the impact of COVID-19.
- 1.4 On behalf of the Assembly, the Chair offered a message of support and thanks to the growing Hispanics, Latinos, and Lusophones communities helping to make London one of the most diverse cities in the world, in celebration of Amigo Month. The Chair also wished Len Duvall AM a speedy recovery from his recent illness on behalf of the Assembly.
