6 Vision Zero (Item 6)

- 6.1 The Committee received the report of the Executive Director of Assembly Secretariat as background to putting questions on Vision Zero to the following invited guests:
 - Lilli Matson, Chief Safety, Health and Environment Officer, Transport for London (TfL);
 - Dr Will Norman, Walking and Cycling Commissioner, TfL;
 - Shravan Joshi MBE, Deputy Chairman, Streets & Walkways Sub Committee, City of London Corporation; and
 - Chief Superintendent Simon Ovens, Roads and Transport Policing Command, Metropolitan Police Service (MPS).
- 6.2 Mayor Philip Glanville, Mayor of Hackney, and Councillor Clyde Loakes, Deputy Leader, London Borough of Waltham Forest, were unable to attend the meeting at short notice. The Committee agreed to submit questions to them in writing and to seek a roundtable with them to ensure input from the Boroughs into the investigation.

- 6.4 Chief Superintendent Simon Ovens agreed to provide the Committee with:
 - Details of any discussions the MPS had held with the Government on reducing the legal limit from 80 milligrams of alcohol per 100 millilitres of blood to 50 milligrams of alcohol per 100 millilitres of blood, as had taken place in Scotland in 2014;
 - Details of any discussions the MPS had held with the Government on allowing random breath testing and police use of mobile evidential breath testing equipment, and the potential benefit of such a policy in London;
 - How the MPS had refocused enforcement on roads during the COVID-19 pandemic; and
 - An update in due course on how plans to designate Police Constable traffic enforcement powers to Police Community Support Officers would benefit the MPS.
- 6.5 The Walking and Cycling Commissioner agreed to provide the Committee with:
 - Examples of why junction adaptations had gone ahead in some areas when critical safety issues had been raised in advance, such as a nil score (the lowest possible score) under the criteria set out by the Safer Junctions Programme; and
 - More details on 'alcolocks' and how these might decrease the number of incidents on London's roads.
- 6.6 The Chief Safety, Health and Environment Officer, TfL, agreed to provide the Committee with more details from the Director of Bus Operations, TfL, on bus driver fatigue, and if this was recorded as a contributing factor in collisions involving buses. She also agreed to provide a breakdown of collision data, with information on the cause, for the Committee to consider.
