 - Further information on the issue of recording anti-social behaviour (ASB) and when that issue was first identified by the MPS;
 - The ethnicities of the children in the eight strip search cases being investigated by the Independent Office for Police Conduct;

- Further information on the operational activity the MPS has undertaken to tackle the issue of bicycle theft, including details of the differences in the approach taken by the MPS and Avon and Somerset Police, who have had success in that area;
- Further information on the prevention of vehicle theft, including the work done to identify 400 streets that the MPS could focus on; and
- Clarification on the responsibilities of the MPS, local authorities and private landlords regarding ASB reports, and further information on when the public should escalate issues and to whom.
- 5.5 The Committee also requested the following from the Deputy Mayor for Policing and Crime:
 - Further information on how MOPAC will measure progress within the MPS on the issues raised in Her Majesty's Inspectorate of Constabulary and Fire & Rescue Services' police effectiveness, efficiency and legitimacy report; and
 - Further information on the Pan-London Anti-Social Behaviour Forum, including the membership, how often it meets and its priorities.
