A. Staffing

4.	Noting that it is a joint decision with the Mayor, to make recommendations to the London Assembly relating to any required disciplinary procedures against the Authority's statutory officers in accordance with relevant procedures.	
5.	In accordance with agreed protocols and at the request of the Head of Paid Service, to appoint as necessary Members to attend appointment panels as non-voting members for relevant staff posts.	
6.	To make recommendations to the London Assembly on any other matter requiring a joint decision with the Mayor.	

B.	Scrutiny

To approve, in accordance with GLA policy, all proposed Assembly-related budget virements in excess of £25,000 (noting that virements in excess of £50,000 will be notified to the Mayor once a decision is taken) and to approve all proposed virements between staff and non-staff budgets within the overall Secretariat budget (in consultation with the Mayor for relevant proposed virements in excess of £50,000).

As the Authority's statutory Standards Committee under s 53 of the Local Government Act 2000 (as amended) ("2000" Act"), to discharge the following functions -		
1.	Promoting and maintaining high standards of conduct by the Mayor, Assembly members, and co-opted members of the Assembly's committees and sub-committees (including advisory ones), and assisting them to observe the Authority's code of conduct, adopted under s 51 of the 2000 Act;	
2.	Promoting and maintaining high standards of conduct by members of GLA staff;	
3.	Promoting and maintaining high standards of conduct by persons who have had or have sought any other type of contractual relationship with, or grant from, the Authority in the preceding 3 years;	
4.	Advising the Mayor and Assembly on the adoption or revision of a code of conduct under s 51 of the 2000 Act;	
5.	Advising the Mayor and Assembly on the adoption or revision of protocols and/or guidance for all staff (including mayoral advisors) and for governing the relationship with persons falling within (3) above;	

6. Monitoring the operation of the above codes of conduct and guidance;
 7. Issuing dispensations to the Mayor and Assembly members under s 81 of the 2000 Act and the Standards Committee (Further Provisions) (England) Regulations 2009/1255 (“the 2009 Regulations”);
-
8. Advising, training or arranging to train, any person covered by the codes and guidance;
 9. Advising the Mayor and the Assembly on the appointment of the independent members of the Committee;
 10. Undertaking any other action that improves, promotes, safeguards or facilitates the highest standards of probity and ethical conduct by the Authority, its Mayor, Assembly members and staff, and those with whom it has, or who seek with it, a contractual, financial or other relationship;
 11. To establish sub-committees under regulation 6 of the Standards Committee (England) Regulations 2008/1085 (“the 2008 Regulations”) for the discharge of functions under s 57A and 57B of the 2000 Act, and regulations 18-20 of the 2008 Regulations; and to determine, or make arrangements for determining, the composition, membership and terms of reference of such sub-committees;
 12. To discharge as a full committee the functions contained regulations 18-20 of the 2008 Regulations where the full committee decides that such functions should not be discharged by a sub-committee established under (11) above;
 13. To discharge as a full committee the functions contained in regulation 17 of the 2008 Regulations; and, where considered appropriate by the full committee, to establish a sub-committee (and agree its composition, membership and terms of reference) to discharge such functions;
 14. Subject to (12-13) above, to discharge or make arrangements for discharging any of the functions conferred upon the Committee under the 2008 Regulations and associated, relevant provisions of Part III of the 2000 Act;
 15. To make recommendations to the Authority as to the establishment, terms of reference, composition of membership and other related matters of any standards Joint Committees or Sub-Committees which the Authority is, under regulations 14-15 of the 2009 Regulations, permitted to establish jointly with one or more participating authorities;
 16. To request that the Standards Board for England exercises its powers of intervention under regulation 3 of the 2009 Regulations;

17. To monitor and exercise a non-financial audit function in respect of:
 - a. the operation and discharge of the functions set out at 11 to 14 above;
 - b. any sub-committees' (established under 11 above) and any Joint Committee's or sub-committees' (established under 15 above) operation and discharge of their functions; and
 - c. the Authority's operation and discharge of the functions exercisable by or on behalf of the Monitoring Officer under the 2008 and or 2009 Regulations, Part III of the 2000 Act, or by virtue of a delegation of Standards Committee;
18. To discharge the function, contained in section 66B of the 2000 Act, of providing information and statistical periodic returns to the Standards Board for England.
19. To conduct an annual review (and report on its findings) of the GLA's operation and discharge of its functions under the 2008 and 2009 Regulations and associated, relevant provisions of Part III of the 2000 Act;
20. In accordance with such procedures as are approved from time to time, to investigate complaints which allege breaches of the Authority's non-statutory codes of conduct, impose sanctions, against the Mayor, Assembly Members, and co-opted members of Assembly committees and sub-committees (including advisory ones);
21. In accordance with such procedures as are approved from time to time, to investigate complaints, and impose sanctions, against any person who has, or who sought, a contractual relationship with or grant from the Authority within the preceding three years;
22. To monitor the registers of the Mayor and Assembly Members' interests as required by the statutory code of conduct, and to monitor the interests of any members of staff who, in accordance with any requirements upon them, are required to declare such interests to the GLA;
23. To advise on the recommendations of the Senior Salaries Review Board about the salaries of the Mayor, Deputy Mayor, Chair of the Assembly and Assembly Members;
24. To agree a Planning Code of Conduct that provides guidance to the Mayor and Members of the Authority on how to act with regards planning matters. It will also agree and recommend to the appropriate decision making body for approval, a Planning Protocol for staff with delegated powers and a Planning Protocol for all other staff. To monitor the operation of the Planning Code and Protocols, to review their operation within 12 months of agreeing the Code and Protocols and thereafter annually, agree and recommend any changes to the Planning Code and Protocols and to advise, train or arrange to train those for whom the Planning Code or Protocols apply.
25. To prepare and recommend a code of conduct for the Authority in regard to dealings with all lobbyists and to monitor compliance;

26. To advise the Authority on good governance standards for public service, and on relevant performance indicators relating to corporate governance systems and processes.
27. To discharge as a full committee or a sub-committee the functions under Section 3A of the Local Government and Housing Act 1989 in relation to grants and supervision of exemptions from political restriction.
28. To review the implementation and operation of the Framework Agreement between the GLA and its Functional Bodies as and when appropriate, and no less than once every two years
