#### 1. INTRODUCTION

This report is provided to the Police and Crime Committee (PCC) for its 13 December 2017 meeting, to assist the Committee to exercise its function in scrutinising and supporting the Mayor's Office for Policing And Crime (MOPAC) and to hold it to account.

This report covers the period from 4 November to 1 December 2017.

In addition to the range of regular meetings and briefings with key stakeholders, including senior Metropolitan Police Service (MPS) officers, below are the main activities I have been involved in and/or where MOPAC has been represented.

#### 2. MOPAC ACTIVITY REPORT

### 2.1 Baroness Young, Independent Advisory Group (IAG)

On 7 November, I met with Baroness Young and Dale Simon from the Black Training and Enterprise Group. We spoke about the next stage in the implementation of the Young Review and the role of the IAG which was set up as a result of the review. We also discussed the recently published Lammy report.

#### 2.2 Sam Gyimah MP

On 7 November, I met with Sam Gyimah MP, Parliamentary Under Secretary of State for Prisons and Probation. We spoke about probation services in London, prisons, electronic monitoring of offenders and criminal justice devolution for London.

# 2.3 Blue Light Collaboration Day

London's Blue Light Collaboration Day was held on 8 November. The Mayor, Fiona Twycross AM and I attended a successful collaboration day which showcased the work of the emergency services in London and how well they work together dealing with operational incidents.

#### 2.4 Annual schools competition

On 8 November, I attended the launch of Show Racism the Red Card's annual schools competition where they invite young people to produce creative work on an anti-racist theme.

#### 2.5 Policing the Community

On 8 November, I spoke at the Howard League's Policing the Community annual conference and awards ceremony. The event was an opportunity to speak with a wide range of stakeholders including those from the criminal justice system, local government and the voluntary sector. Some of the key issues covered in my speech included work MOPAC is doing to deliver on the commitments in the Police and Crime Plan to reduce offending and tackle reoffending.

# 2.6 Survivor roundtable

On 8 November, MOPAC was represented at a survivor roundtable session facilitated by Claire Waxman, the Victims Commissioner for London, to discuss the recommendations made in the survivor consultation.

# 2.7 Priority boroughs meeting

On 9 November, I chaired a meeting of local authority and borough police representatives from London boroughs which had been highlighted as priority boroughs for tackling Violence Against Women and Girls (VAWG).

#### 2.8 100 Years of Women in the BTP

On 9 November, I spoke at the event celebrating the 100-year anniversary of Women in the British Transport Police. The speech was an opportunity to celebrate the progress that women have made in our emergency services and welcoming the appointment of Cressida Dick, as the first female Met Commissioner in 188 years and Dany Cotton, becoming the first female Commissioner of the London Fire Brigade.

#### 2.9 Annual Service of Remembrance

On 10 November, I attended the MPS Annual Service of Remembrance to pay respect to those officers who had fallen in the line of duty.

#### 2.10 Round table meeting on VAWG

On 13 November, I attended a session with a mixture of partners, Voluntary, Community Sector (VCS) colleagues and stakeholders – seeking their support in delivering the refreshed VAWG strategy. The purpose of this roundtable session was to test the policy sections and commitments made within the emerging Violence Against Women and Girls (VAWG) strategy. It was also to emphasise the need for their support and partnership to tackle VAWG in London.

#### 2.11 Independent Custody Visiting

On 14 November, I delivered the opening speech at the Independent Custody Visiting Association's Annual Scheme Managers' Conference. The Conference was attended by Scheme Managers from Police and Crime Commissioner offices across the country and showcased the important work of custody visiting.

#### 2.12 Leading for London

On 14 November, I met with MPS staff responsible for delivering 'Leading for London' – a development programme to improve leadership at all supervisory levels within the MPS.

#### 2.13 Night-time economy

On 14 November, I met with Justine Simons OBE, Deputy Mayor for Culture, and Amy Lamé, Night Czar, to discuss a number of policing and other issues relating to the night-time economy.

#### 2.14 Institute Launch

On 15 November, I gave the opening speech at the Launch of the Institute for Global City Policing. Professor Ben Bradford gave the inaugural lecture on 'Diversity in Policing'. The event was attended by an audience from policing, academia and policy.

# 2.14 Knife Crime Strategy Launch

On 15 November, the Mayor joined young Londoners taking part in a creative workshop at Photofusion in Brixton to deliver a key commitment from his Knife Crime Strategy, launching a new campaign – **'London Needs You Alive'**. London Needs You Alive puts forward a positive message and aims to influence young Londoners to make an active choice not to carry a knife. The campaign – backed by a video – highlights how valuable young people are to London, to their family and friends and how, by using their talent, and not picking up a knife, they can accomplish great things.

On 15 November, I also met with Sarah Jones MP, Croydon Central. We spoke about the All Party Parliamentary Group on Knife Crime and the Mayor's Knife Crime Strategy.

#### 2.15 LGA Violent Crime Conference

On 15 November, I spoke at a conference of Local Government Association (LGA) members on the subject of 'Addressing Knife crime'. The speech outlined the update in the Mayor's Knife Crime

Strategy, including the launch of the anti-knife media campaign, and the importance of working across agencies to reduce violent crime.

## 2.16 Contextual Safeguarding

On 16 November, I spoke at the launch of a report into Contextual Safeguarding, held by Safer London. The report outlined the findings from a pilot project, safeguarding young people against exploitation and harassment in public spaces like shopping centres.

### 2.17 Met Intelligence

On 17 November, I met with the Operational Command Unit (OCU) team and was accompanied to other functions, including the Communications Intelligence Unit, 24/7 intelligence support, Public Order Intelligence Unit and received verbal briefings from members of Wildlife Crime Unit and Safeguarding officers.

## 2.18 Community Security Trust

On 17 November, I met with Richard Benson OBE, former CEO of the Community Security Trust and now leading Maccabi GB, a Jewish community sports development organisation. Richard has been recently appointed by the Government to lead a new Challenging Hate Crime Support Group with the aim of building skills and capacity within the grass roots community and voluntary sector to tackle hate crime. I look forward to continuing to work with Richard to meet our shared goals on this important subject.

### 2.19 Modern slavery

On 20 November, I attended the launch of a new report into the nature and extent of modern slavery in London. I spoke about the work that City Hall is doing to tackle modern slavery. In attendance was Vernon Coaker MP, experts from the sector and a victim of modern slavery who told of her harrowing experience in order to raise awareness of this important area of work.

#### 2.20 IPCC

On 20 November, I met with Dame Anne Owers, Chair and Sarah Green, Deputy Chair of the IPCC for our regular quarterly meeting. A number of issues relating to the oversight of professional standards within the MPS were discussed.

#### 2.21 Neil Coyle MP Knife Crime Event – House of Commons

On 22 November, I attended a meeting with Neil Coyle MP, Southwark Borough Commander Simon Messenger, Southwark Local Authority representatives, a number of community group leaders and bereaved parents. The meeting was to discuss the Mayor's Knife Crime strategy, the recently launched anti-knife crime media campaign, and Southwark's specific actions and priorities for tackling knife crime. This provided community representatives the opportunity to share their insights and ask questions of partners.

#### 2.22 Visit to HM Wandsworth Prison

On 23 November, I met with the Governor of HMP Wandsworth, Jeanne Bryant, as well as staff and inmates. We discussed the current challenges facing London prisons for staff and offenders.

#### 2.23 Trident and Area Crime Command Commendation Ceremony

On 24 November, I was a guest speaker at the Trident and Area Crime Command Commendation Ceremony. The purpose of the ceremony was to commend Trident officers for their outstanding detective ability, resilience and professionalism and to do so in the presence of their invited guests and the Trident senior leadership team. Sixty five officers were commended.

#### 2.24 Manchester Devolution visit

On 28 November, I visited Barton Moss Secure Care Centre, and then met with Baroness Hughes, Deputy Mayor for Policing and Crime in Greater Manchester. We discussed areas of mutual interest.

# 2.25 Trident Matrix/BAME Briefing

On 29 November, I met with Jennette Arnold OBE AM, Deputy Mayor Matthew Ryder and senior representatives from MPS to update them on the activity and timescales of the Gangs Matrix review. The meeting followed an offer from the Mayor during Mayor's Question Time (MQT) relating to the Matrix review in the context of publication of the Lammy report.

# 4. Finance and Performance Report Q2 2017/18

- 4.1 Finance details are provided as part of the Quarterly Performance Update.
- 4.2 The report presents information and its structure is aligned with the Police and Crime Plan (PCP). The performance sections provide quarterly and annual trends on crime in London and how the MPS are providing a better Police Service for London.
- 4.3 The finance section starts from page 37 and provides a detailed breakdown of the Q2 financial position whilst also providing longer term trends. The Finance section includes a breakdown of Revenue, Capital and Reserves positions.
- 4.4 This updated report has been included as Annex [1] and a summary of Financial position has been provided below:
  - 4.4.1 At end of Q2, MOPAC Group is reporting a net underspend of £17.7m (Q1 reported a net underspend of £32.2m). Key assumptions are:
    - 1. £26m of police officer pay is forecast to be transferred to earmarked reserves, to provide for the additional 1% police officer pay rise until August next year (and beyond, in the event that the increment is repeated) and protect funding for medium terms officer recruitment plans.
    - The forecast position is based on counter-terrorism and protective security expenditure being fully funded, and the Government providing additional Special Grant for the additional policing costs associated with Grenfell Tower. Note that if this funding is not forthcoming, the Met will be required to fund the additional costs from existing budgets.
    - 3. There are also risks of additional costs in relation to a number of ongoing commercial and contractual disputes. The Met continue to work through resolutions and the potential costs.
  - 4.4.2 Capital investment is forecast to be £218.4m, against an approved budget of £268m.
