- 5.2 Nick Simmons, Chief Executive Officer, RoadPeace, and Zoe Courtney-Bodgener, Policy and Campaigns Officer, RNIB, were also invited but were unable to attend. The Committee agreed to submit questions to them in writing, particularly regarding the experience of vulnerable road users and people with disabilities.

- 5.4 The Chair of London Living Streets and Action Vision Zero agreed to provide the Committee with research around the impact on vehicle speeds in London and across the UK where local authorities had instigated 20mph speed limits, and examples of successful road safety initiatives from across the UK.
- 5.5 The Chair of MAG agreed to provide the Committee with a copy of the *What is MAG?* statement, which provided more detail on their work.
- 5.6 The Director of Policy, Northern Europe, Lime, agreed to provide the Committee with evidence from around Europe on the breakdown of users of e-scooters as opposed to users of bikes or
