Title: Confirmation Hearing for the Office of Deputy Chair of Transport for London

1. Executive Summary

- 1.1 In accordance with the Assembly's Standing Orders and the provisions of Schedule 4A to the GLA Act 1999 (as amended), the Chair of the Assembly has delegated authority to: (i) decide whether to hold a confirmation hearing for the Mayor's candidate for appointment to the office listed in Section 60A(3) of the Act; and (ii) to request that the Mayor's candidate for appointment produce, under paragraph 6(4) of Schedule 4A of the Act, documents that relate to his or her proposed appointment.
- 1.2 The Chair of the London Assembly received a letter from the Mayor on 10 May 2024 (dated 9 May 2024) indicating his intention to reappoint Seb Dance to the office of Deputy Chair of Transport for London (TfL). A copy of the letter from the Mayor is attached at **Appendix 1**.
- 1.3 Following receipt of the letter and informal consultation with party Group Leaders, the Chair of the London Assembly has decided to hold a confirmation hearing in relation to this proposed appointment, and to ask the candidate to provide a CV and supporting statement. Copies of the Chair's letters to Seb Dance and the Mayor are attached at **Appendices 2 and 3**.
